PUBLIC HEARING

MODIFICATION OF THE BASEMENT REGULATION LOCAL LAW § 165-44 A (2)

Presented by Supervisor Oliverio

Amendment of Local Law §165-44 A (2), states:

§165-44 A. Nonconforming structures.

- A. Changes, alterations, additions and/or repairs to all existing structures that are nonconforming, whose setbacks are nonconforming, or are on lots that are nonconforming and that were built prior to the effective date of this chapter shall be permitted, provided that:
 - The nonconforming front, side and rear setbacks are not decreased, and no additions in height or footprint are made to any side of the structure where a setback nonconformity exists.
 - 2. The added living space shall not exceed 20% of the existing livable floor space <u>except</u> when the space is in the basement within the footprint of the residence.

The effect of this language will exclude improvements that require approval of the Planning Board for construction as set forth above.

Town Council Florence explained what the modification by saying what we are talking about is that anyone who wants to improve their basement and even if it is the full basement, as long as you don't expand beyond the original footprint of your foundation, you do not have to go to the Planning Board anymore which will save time and money. What does it not say? It does not say is that you don't need a Building Permit. It does not say that the Building Inspector will come and issue a CO on that improvement. You are simply eliminating a step to make it a little easier for the people of the Town. You are skipping a step by not going to the Planning Department anymore, you are only going to the Building Department.

Supervisor Oliverio asked for any public comment only on the 20%.

A resident, Patty Villanova spoke at the podium.

Ms. Villanova asked for a clarification in Section A which mentions preexisting nonconforming homes that were build prior to the date of this chapter. She is not sure why there is a distinction between a preexisting structure and one built after this law. She would also like a clarification in Section 2 which mentions added living space in the basement. It sounds like you actually could, in the basement, add an addition or make an alteration that is more than 20%. That's why laws and words have meaning. Supervisor Oliverio and Councilwoman Whetsel explained that any and all work done, even if it is the whole basement must remain in the original footprint of the home. Council Florence explained that you can improve the whole basement without going to the Planning Board; you still need to get a Building Permit if you are doing something structural. You would need to get a CO for that structural work. If you are putting a bathroom down there, you would need a plumber who has a license as well as a licensed electrician. The 20% is for people that are going to change the size of their home. It is for those who will be building up or out, they need permission from the Planning Board because we have a number of lots with neighbors who live quite close together and their improvements may be offensive to their neighbor. The difference between nonconforming and people, who construct after the law is that the very early home, didn't have a standard by which to build, (i.e. a home built in the 1920's,) so we don't go in there and say you have a violation – you get an exemption for that. You are allowed to keep that. Ms. Villanova wondered what if someone with one of these older homes wants to build an addition, does the building Inspector only look at the new addition, and are they going to ignore what was there before. Council Florence replied, the Building Inspector will decide if the person has conformed to whatever the plan was and give that owner a CO for the basement only.

Supervisor Oliverio moved to close the Public Hearing Councilman Mackay seconded, unanimously carried.
