### **DEPARTMENT REPORTS**

Presented by Councilwoman Jackie Annabi

Larry Cobb, Highway Superintendent reported that a 24" pipe on Oscawana Heights Road has been changed because it was much rotted. A 36" pipe on Wood Lawn Road was also changed for the same reason. The Highway Department is still working on cleaning catch basins. The mowers are also out now. Kramer's Pond Road is ready to be blacktopped, be patient as there will be some delays; we plan on starting around August 8<sup>th</sup>.

Kathleen McLaughlin from the Putnam Valley Free Library said that the Mid-Hudson Library System now has established e magazines which can be downloaded like books. The entire magazine including ads can be downloaded. There are a lot of summer programs going on. There will be a movie tomorrow night. The first movie begins at 5 PM and the second movie begins at 7 PM in the community room. This Saturday, the llamas are coming back from 12 noon to 2 PM - with an ice cream party directly afterward. Please register so there will be enough ice cream. All our events are posted on the Libraries Facebook page. A representative from the Putnam County Community Action Program will be at the Library to talk about Health Care Plans, please come and talk to them you may be eligible for free or low cost health insurance. A grant was written for the pedestrian bridge and \$33,000.00 was awarded and will be given to the library next year. The pedestrian bridge will be built before the vehicular bridge, this way there will still be access to the library. These projects will be brought before the Planning Board on

August 8<sup>th</sup>. Also a grant of \$8,000.00 from Bullet 8 (which the Republican Legislature gives out) was graciously granted to our library, and is much appreciated. This was a grant we did not apply for - it was just given to us. Storytime is back on for the summer and all events are also listed on the Town's Website.

The next Department Report is from Fire Department Chief Shawn Keeler.

Chief Keeler reported on the Fire Department's month of April 2016 calls: 157 days to Christmas!

8 motor vehicle accidents

1 fuel spill leak

4 wires down

1 rubbish fire

2 vehicle fires

1 structure fires

3 automatic alarms

6 good intent calls

5 EMS assists

31 for the month - 210 year to date. Sadly, this is 32 more than last year. The Department has spent 413 hours out at these calls plus much more at drills and work details. In the last few months we had some people taking Firefighter One which is a very difficult course, everyone passed – congratulations. There were other members who also took various courses and all passed. Remember swimming safety this time of year. Also if you are planning on going away you can have a nox box attached to the outside of your house. You put a house key inside and the other key goes to the Fire Chief. If something happens at your home the Department would have the ability to get into your home if necessary. 911 would have to release the box. If you would like a nox box please call Chief Keeler at 845-526-2879. Don't forget the Fire Departments 70<sup>th</sup> anniversary parade on October1st at 2 PM.

Councilwoman Annabi reminded everyone that the next Sunset Series Concert is on Friday, July 29<sup>th</sup>. There are only three (3) concerts left, these events are free. July 30 at the Tompkins Corners Cultural Center at 7:30 PM there is an event.

### SUPERVISOR'S OPENING COMMENTS

Reminder - Town Day is September 17<sup>th</sup> from 4-9 PM. All not- for- profit groups please get an application on our website. We are going back to an Old Tyme Town Day with concerts and fireworks. Two weeks later is the Fire Department Parade and 70<sup>th</sup> anniversary celebration.

Email alert - go to our webpage and sign up for email alerts; there are almost 300 families signed up for this.

We have dunks! A dunk will kill all mosquito larvae in a 10 x 10 square foot area. This will only harm mosquitos. This is great for all standing water such as baby pools or bird baths.

Our medication drop off box has collected over 100 lbs. of medication so far. Get rid of all that old stuff from your homes. We don't take sharps or liquids in glass. Councilman Mackay announced that the light at Adams Corners is now working again. He would like to thank Supervisor Oliverio, Legislature Gouldman and Larry Cobb for being diligent.

### **PROCLAMATIONS:**

Mark Yetter – his outstanding project was building two (2) boat ramps at Carrara's Beach in Lake Peekskill. Councilman Mackay said that this accomplishment will serve you through college and beyond. Councilwoman Annabi said that he is a phenomenal young man and we are grateful for the job you have done.

Stephen Brown – His amazing project was putting a huge running track at the High School dedicated to Caitlyn Bagnato who lost her battle with cancer. This is a great way to always remember her. The property he cleared was very overrun and hard to get to, so this was not an easy task.

Supervisor Oliverio gave a proclamation to Mrs. Berz's family to give to her on the occasion of her 101<sup>st</sup> birthday. She was born July 23, 1915.

He also said that the Oscawana Lake Road repave project should be done shortly. It was a long process. ## <u>PRESENTATION BY PUTNAM COUNTY CONCERNING CELL TOWER NEAR SENIOR</u> CENTER

Supervisor Oliverio introduced Mr. Sutton, Commissioner of Emergency Services, Tom Landon, Director of IT for Putnam County and Captain Frank Christian from the Sheriff's Department. They have been working for many years on a communication project within Putnam County. They are in the very beginning stages of looking for a place to put four (4) cell towers to enhance communications in Putnam County. Right now they are looking at the Senior Center property in the Town Park for one of the placements. A lot of studies have been done. They are looking to go to a trunking system which would give them better communication. Now they are looking to see where they could erect towers needed to enhance the emergency system. Four (4) sites around Putnam County are being investigated. There would have to be a public hearing at each site before the project could move forward. The Putnam County Legislative Committee will be the lead agency on this project. County Executive, Mary Ellen O'Dell would like to hear from

the public, and feedback is needed before anything else is done. She wants this to be an open process with the public being well informed along the way. The bottom line is the more towers the better the coverage for our emergency services. The old system has been experiencing problems for years. The new cell towers would have antennas on top so the microwaves can link the towers and spread the signals out so all the emergency services can get the messages and nothing is dropped. This makes everyone coordinated and makes our residents safer. Mr. Sutton said that this is a system that has been struggling for 40 years and recently a 3 ½ million dollar grant for a microwave system (which expires December 31, 2017) was received, so time is an issue. We are worried about the current system- we will continue to maintain it but we need to move ahead. The sites that have been selected are all on County owned property. This County has many challenges with the amount of hills and mountains in the area. There are very serious holes in the current communication system throughout the County. We need a line of site connecting the different towers. This means the towers would have to be in the right places to shoot a microwave signal for one tower to the next which would make a big circle throughout the County - so the towers have to be strategically placed. At present, with our communications system on poles, they are subject to cars hitting the poles and taking them down or back hoes accidentally digging up the wiring. The transmission equipment will be stored in a little air conditioned house on the property. Rent will be charged to any cell phone company such as Verizon or other cell phone carriers which is also beneficial to the residents of the County. Councilwoman Whetsel understands the benefits and the challenges but is concerned about the health risks that may be a side effect of the microwaves. The response was that cell towers have been around for 20-25 years and there is no data either way. Councilwoman Whetsel suggested they put the tower in a place where there are not a lot of people. Supervisor Oliverio suggested an uninhabited parcel the Town owns on Piano Mountain as an alternative spot for the Tower. The Representatives said that they will look into that. They still need the environmental reports and other reports as well before they can proceed – this will be a transparent process. Supervisor Oliverio asked when the Public Hearings will be held. The response was in a couple of months. Councilman Mackay said that no one lives in the Park and there is no definite science on the health risks. He added that the Deputies need to be in contact with Carmel at all times and that there is no choice here. Councilwoman Annabi cited all the dropped calls that occur on Mill Street alone. She stated that the Officers need reliable communication; and you can't leave calls unanswered. Highway Supervisor Cobb suggested a vendor that the Fire Department uses that they find gives great signals which is called Goosetown.

# **DISCUSSION FOR PUBLIC HEARING ON CIVIL FINES FOR BUILDING VIOLATIONS**

Presented by Councilwoman Annabi

### **Discussion**

A Public Hearing has been set up for August 17<sup>th</sup> to discuss raising the civil fines on building code violations. The fines will see increases up to \$3,000.00 for multiple infractions. These fines will only be imposed on people who break these codes knowingly.

### **VOTE ON SMOKING RESOLUTION**

Presented by Supervisor Oliverio

We had a public hearing and this law will make it illegal to smoke in the Town Park or at the Town Beaches. It will take effect on October 2, 2017, so there would be time for people to become aware of this and signage could be put up.

Councilman Mackay gave a second for discussion. He asked if this law includes vaping too. After reading the law as is, Councilman Mackay concluded that this does include vaping as §44.2 states that what is outlawed is any smoking material where smoke is exhaled. Supervisor Oliverio said that vaping was not discussed at the Public Hearing and what comes out of an ecigarette is water vapor. He added that this could be added on later. Councilman Mackay says it is an incomplete law and he is not sure how it can be enforced. Councilman Luongo is also not happy with the law as written. He feels that there should be sections in the Park where smoking ia allowed, far away from the fields, like in the parking lot. You could make an area on South Street so you can see your child play and still be far enough away to enjoy a smoke. Our park is huge. He is looking for a little leniency. Supervisor Oliverio says that no parks in the County allow smoking anymore; and he sees no good argument to allow smoking anywhere in the park. The cigarette butts will still be making a mess as well. People can walk to the end of the road if they really need to smoke. He added that you can smoke in your car in other parks but that is as far as it goes. Maureen Kenny, Director of POWER Against Tobacco spoke. She stated that this agency is part of the American Lung Association of the North East, which is funded by the New York State Bureau of Tobacco Control, under the auspices of the New York State Department of Health. She concurred with Supervisor Oliverio that you can only smoke in your own personal car in Putnam County Parks. If you do see people smoking in the driveway of these parks - that is not part of the law, and is not built into the law. Councilman Luongo was satisfied now with people's ability to smoke in the car. He is a little more at ease now. He understands the benefits but he wants smokers to be shown respect as well.

**RESOLUTION #R16-253** That the Town Board authorize the Supervisor to sign into law the following:

Chapter 44: Smoking

Parks and Public Beaches:

### §44.1 Purpose.

The purpose of this article is to prohibit smoking at all Town of Putnam Valley Parks and their facilities as well as on the public beaches owned or operated by the Town of Putnam Valley, and/or any of the Town of Putnam Valley Park Districts and their facilities. The Town Board hereby finds that a potential health hazard exists from allowing smoking on said beaches both from smoke and from the debris created by discarded cigarettes and other smoking materials.

### §44.2 Smoking Prohibited.

The smoking or carrying of lighted cigarettes and other smoking materials, including but not limited to cigars, pipes and the like in which smoke is exhaled, at all Town of Putnam Valley parks and their facilities, as well as on the public beaches owned and operated by the Town of Putnam Valley and/or any of the Town of Putnam Valley park districts and their facilities is hereby prohibited.

### §44.3 Penalties for offenses; enforcement.

- a. Any person convicted of a violation of this article shall be guilty of a violation and punished by a warning for a first offense.
- b. Any person convicted of a second violation or more of this article shall be guilty of a violation and punished by a fine of not more than \$50.00 for each offense.
- c. The Putnam County Sheriff's Department, or any other agency, officer or employee designated by the Town Board by resolution shall be charged with the enforcement of this article.

### **DISCUSSION OF LICENSING TOW TRUCKS IN PUTNAM VALLEY**

### **Discussion**

Councilman Mackay would like Council Florence to put together an ordinance or a licensing fee to regulate tow truck operators in the Town of Putnam Valley. The fees that are being charged to car accident victims are high and insurance companies may not cover this. Many tow trucks that are coming are from out of town; and sometimes you have to go a long way to get your car back. This would also protect our local businesses. Our local town tow truck businesses should pay \$50.00 for a yearly license and much more should be charged to out of town tow truck businesses. We should show an allegiance to our local companies. Councilman Luongo would also like a schedule of fees added. He said if you break down on the Parkway the State regulates that and you pay almost nothing. Council Florence wants to make sure the Sheriff's Department and the State Troopers know we have this when it's completed. Council Florence added that the dispatchers are the ones who call the tow trucks after an accident; and if they have a friend on that list they may get the majority of the calls. Supervisor Oliverio said that we would like to prevent that from happening; that's why we want this. We don't want to see our towns people abused. Council Florence gets it together we will have a Public Hearing on it.
