COUNTY LEGISLATOR'S REPORT

Presented by Supervisor Oliverio

County Legislator Scuccimarra reported that she continues through the Health Committee to work on the ban of synthetic drugs such as synthetic marijuana. The difficulty of this is the scope of these synthetic drugs changes all the time - so every time you designate one as illegal another one pops up. Westchester came up with a sound law that she is trying to get Putnam County to follow. Anything we can do is important. Doctor Nesheiwat came back from Albany and said that Putnam County is ahead of the Clean Air Act as far as e cigarettes are concerned. We put e cigarettes in with our smoking prohibition in public areas. E cigarettes are becoming a problem because of vaping and everything that people are throwing into them. The County is considering getting on the list along with other Counties to sue the manufacturers and pharmaceutical companies that make opioids. We are not doing this for monetary gain; but the more people that get in on this lawsuit helps send a message. Senators Gillibrand and Murphy are signing off on the five (5) day rule; which is awesome. We have to change other things as well. When people come into the hospital they are asked what their pain level is from 1-10. If someone says an eight (8) they have to be treated as such whether it is true or not. We need to change how we determine pain levels so we don't treat unnecessarily.

November is America's Recycle Month. Legislator Scuccimarra said that when you use those big recycle bins for plastic bags in supermarkets you can also put other plastic waste in - such as bubble wrap, dry cleaning bags, produce bags and those packing bags that are filled with air.

In 2015 Legislator Scuccimarra initiated a ban in all County Facilities eliminating the use of all polystyrenes. There is a movement now, and Dutchess County just passed a law, that any chain restaurant with more than 15 stores nationally cannot use Styrofoam. She is looking for Putnam County to do the same. They don't want to burden people with extra cost, but you have to look out for people's health.

The Mortgage Tax Report is in and Putnam Valley will be receiving \$140,000.00 in mortgage tax so that's always a bump.

Councilman MacKay said he and Supervisor Oliverio were at a meeting at the High School last week where vaping was discussed. The School District said it is hard to control because it doesn't smell like cigarettes so kids can use it in the hallways and in the bathrooms. It is becoming extremely wide spread. Another reason it is such a serious issue is that they are putting other things in them like hash oil; these are narcotics, so they are getting loaded. Parents need to be made aware of what is going on. It's all an education for students and parents as well.

Supervisor Oliverio said when he left the Legislature over two (2) years ago he was worried about the Heath Committee which he was on for the 18 years he was a Legislator. He is so happy that Legislator Scuccimarra has carried on the tradition in such a great way. He is very proud and said you have upheld the tenets that the Committee stands for.

PUBLIC COMMENT

Presented by Supervisor Oliverio

Resident Anthony Williams, Secretary of the Putnam Advisory Council of the Salvation Army, said that we have brought back the Salvation Army to serve Putnam County. We are going to be having a press conference to announce this on Tuesday, November 28th at 11:00 PM from the Department of Motor Vehicles in Carmel. The Holidays are coming up and those days can be difficult for families with lower incomes; to that end we are bringing back the "Angel Tree Program" which gives toys to children ages 12 years and younger. In addition we are also bringing back the Christmas Food Basket Program – there are applications to fill out which will be available on Thursday, November 30th at the Putnam Valley High School from 5 PM – 8 PM. Informational flyers will be available at both at the Town Hall, and Putnam Valley Library. You can also E-mail any questions you have to Saputnam@gmail.com or you can call me directly at 914-886-8958 - you need proof of residency, an ID for each eligible child and proof of all income. We are also looking for volunteers to help with the kettle bell program. Terry Raskin asked how the average citizen can donate to this. Mr. Williams said right now we are still setting up our distribution location in Putnam Valley. If you have donations of clothing the truck can pick those up. If you have monetary donations, food or toys please contact us by email and we can arrange to pick those up.

Resident Eileen Reilly said she came to Putnam Valley because it was peaceful and safe. She did not have to lock her doors or her car. Now it is not the same and there has been a lot of crime recently.

She is now afraid to leave her doors and windows unlocked. She heard that there is one (1) Sheriff in Putnam Valley and asked if this is correct. Supervisor Oliverio said no, we have an SRO at the Schools five (5) days a week. Also the patrols alternate sometimes two at a time, and they exchange and interchange back and forth." Do we have a set singular patrol to go through neighborhoods - which we do not have"? Ms. Reilly thinks we do need that. Councilman MacKay said we do have State Police here with an annex across the street but they do mostly speed enforcement.

He agrees that the crime here has changed to a more violent nature so maybe we do need to meet with the Sheriff and talk about this. The Town Board agreed that this is a concern of a lot of people. Ms. Reilly also reminded everybody that November 25th is Small Business Saturday. On November 18th the Putnam Valley Business Network will be going out with little shopping bags filled with samples from local businesses. Please be mindful of "shop local" - there are a lot more businesses here than people realize. Councilman MacKay added that on November 25th and 26th from 10 AM – 3 PM Neise's Maple Farm is having an open house you need to go to.

Councilwoman Annabi announced the Parks and Recreation holiday event in the Park is on December 8th at 6:00 PM. Please call 845-526-3292 if you have any questions.

Councilman Luongo announced the Volunteer Fire Department's Annual Santa Claus Run which is being held on Saturday Dec 16th starting at 8:40 in the morning. You can find the times on the scroll on Channel 20. There is also a boot drive on that day to support families who need some help during the Holiday Season. The Fire Department is also raffling off a snow blower. You can buy a raffle for \$5.00 a ticket or 5 tickets for \$20.00. Please call Councilman Luongo at 528-9148 if you are interested.
