DEPARTMENTAL REPORTS

Presented by Councilwoman Annabi

Councilwoman Annabi noted that Chief Keeler was not at the meeting yet but wanted to thank him for all the time he has given the Fire Department and the Town. David Anderson will be the new Chief beginning in January of 2017 so the Town Board wanted to give Chief Keeler all the accolades he deserves. He is not leaving the Department and will still serve our community as valiantly as he does now.

Councilwoman Annabi also announced the Fire Department's Candy Cane Run will take place this Sunday. It begins at 8:40 AM at Cranberry Commons, and continues throughout the Town until late afternoon. Please check Channel 18 and Facebook for what time Santa will be near you.

Chief Keeler arrived at the meeting and reported on the Fire Department's month of November 2016 calls:

He also mentioned that this weekend is the Fire Department's Boot Drive. All the money that is collected goes to needy families in Town. On a personal note, Chief Keeler said he became Assistant Chief on January 1, 2008, he then became Chief, and he will have served for nine (9) years. He wanted to say thank-you to his wife, Melissa and his four (4) children. He also thanked this Town Board and previous Town Boards for their support. He thanked this Fire Department's Board of Directors as well as past Board of Directors for their support and added that it was an honor to have served Putnam Valley in this capacity. Please be careful driving in the snow, stay home if you can.

Highway Superintendent, Larry Cobb, was unable to attend; but sent his warm wishes for a happy holiday to everyone.

PROCLAMATION – DR. WILLIAM ZURHELLEN

Presented by Councilman Mackay

Dr. William Zuhellen was unable to attend tonight – so his Proclamation will be given to him at the meeting on the 3rd Wednesday of January. Councilman Mackay said that Dr. Zurhellen is the Town's retiring Pediatrician and it is tough to see him go. He has been part of this community for 40 plus year. He was also the Doctor at the School for many years. He is an incredible man and an incredible Doctor and we will talk more about it next month. This is a personal loss and a loss for the whole Valley.

COUNTY LEGISLATOR'S REPORT

Presented by Supervisor Oliverio

Supervisor Oliverio said that the two (2) County Legislators could not make it tonight because there are two (2) major committee meetings going on. Councilwoman Annabi stated that she wants to acknowledge the new Putnam County Animal Abuse Registry which is a great thing. This legislation came from County Legislator Gouldman, and we want to thank him.

SCHOOL DISTRICT REPORT

Presented by Supervisor Oliverio

Dr. Wills began by saying that over this past weekend there was a special festival at the Barnes and Noble on Route 6 which was very well attended by students who put on a performance. She also attended the Historical Societies Pearl Harbor Lecture and thought the author was very engaging. Yesterday our students went to our Senior Center and a Nursing Home to sing to everyone. There were 30-40 students who participated. The students brought much good cheer. We had four (4) students on a technology team who went to the Digital Arts Center in White Plains to compete against other student teams. Alan Brody was the sponsor. His wife was killed in a tragic train accident last year due to an incident with the rail crossing. The competitions theme was to develop new technology to make rail crossings safer. There was a \$500.00 prize and our High School won. In addition, we had a first soprano that made it into All State this year. We are very proud.

Dr. Wills discussed said that there is currently a High School Later Start Committee. This is a 34 member team which is studying insufficient sleep in adolescent brains and how it affects their learning. They would like to start the High School at a later time in the morning. Research shows that adolescent's brain rhythms are not made to get up this early in the morning. Starting later would benefit their mental health and ability to achieve. The research shows that the early wake time inhibits the student's ability to achieve. There is a meeting tomorrow night at 6:00 PM before the School Board Meeting where this will be discussed. A decision will be made in January. If this goes through this will be a 40 minute change, and will require four (4) new buses. As far as cost, there will be a \$250,000.00, increase due to the four (4) additional buses needed but this will not impact your taxes. Dr. Wills added that there will be 17 retirements at the end of this school year so those extra funds can be applied to this. This is all being done for the student's health, academic achievement and well-being. Some people are concerned that children in grades 5-12 will be riding the bus together; but she finds the older children look out for the younger children. This situation already occurs in Roaring Brook. There are two (2) videos which will be sent to Maryann Arrien to show on our public access channel as well as a hand out which can be read. Whenever a change is made, there are always problems that have to be solved. It is a major undertaking.

Councilman Mackay reminded Dr. Wills to mention that the technology teachers set up "our code" which is a program where parents and students learn about computer coding. These are the kinds of things that bring the community into the schools.

<u>AUTHORIZE SUPERVISOR TO ADVERTISE FOR THE DEMOLITION OF WATER</u> <u>TOWER, PUMP-HOUSE AND ALL PIPES RELATED TO TAX MAP PROPERTY 62.15-1-53 IN EXCHANGE FOR THE PROPERTY.</u>

Presented by Councilman Luongo

Seconded for discussion by Supervisor Oliverio.

Supervisor Oliverio acknowledged that there are some Wildwood Knolls Residents here who have come to voice their opinion.

Jayne Reis, a Representative from the Wildwood Knolls District, went to the podium to speak. She said they had a meeting last Friday night to which they invited Councilwoman Annabi, who was unable to attend due to prior commitments. The meeting did not have a big turnout because this is a very busy time of year. She added that she knows the Town wants to move quickly on this, but she is asking them to slow down because there are members of their community who are unsure about how the land became the property of the Town. Supervisor Oliverio said that a title search was done by the RG Agency, (a copy was given to Ms. Reis), which went back to the very origins of the Wildwood Knolls District and found that the Town of Putnam Valley for the fee of \$10.00, purchased the property from the Lake Oscawana Realty Corporation so that the District of Wildwood Knolls could build their water tower. The title search confirmed the Town owns it, and our own insurance confirms that the Town is liable for it. The problem is that this is an area that is abandoned and is an attractive nuisance. Our Insurance Company said that once the water tower, pipes etc. are removed our liability will be greatly reduced. We don't want the District to do it. The decision to trade the property for the work was made more than 2 years ago. A stipulation can be put in because it is only ¼ of an acre that it is not a buildable lot. Supervisor Oliverio said that the Town is not moving fast, and the ad can ask for the bids to be submitted by February 1, 2017. We can give the winner six (6) months to get the work done. If Wildwood Knolls can get together and get a contractor and put in a bid they can be first choice. The amount of money needed to do this project is about \$31,000.00. Ms. Reis felt that this is a lot of money and the District may not be able to get that amount. She added that many residents of Wildwood Knolls are not around in the winter. Supervisor Oliverio said that the Town sent out 75 letters to tell Residents what was going on and did not get any back.

Ms. Reis says the committee needs more time and they do not want to lose this property for the District. Supervisor Oliverio said the Town itself can't take it down because we cannot expend Town dollars on a District liability just like in Lake Peekskill. He further said that we can postpone the submittal of the bid until April 1, 2017. We can go out to bid, have a District Meeting in March on a Saturday to further discuss this, and have the bids open on April 1, 2017. This gives the District a chance to get a bid together. Supervisor Oliverio said if you can find a licensed person willing to volunteer you will be able to keep the price down.

Resident, Tom Carano who used to do this for a living spoke next. He took a photo of the water tower and apparatus which he showed to the Town Board. He said that the property is actually .43 of an acre which is not small. He added that he did not see a keep out sign or no trespassing sign anywhere on the property. He said that from his experience the tower and accompanying apparatus could be taken down on one Saturday. He also added that if the property was sold instead of being given away that money could go into the Town's coffers. He felt that the Town would be able to get at least \$50,000.00 for the property. Supervisor Oliverio reminded him that everyone working on this needed to be licensed and bonded in the County. Mr. Carano said there is 5 tons of steel there that could be sold as well. He asked why the Highway Department was not doing the job. Supervisor Oliverio said that Mr. Cobb did not want to risk his men on something they don't know anything about.

Councilwoman Annabi said that this topic was first brought up in a 2011 District Budget Meeting. It was stated at that meeting that this area was a hazard and an eye sore. The District did ask the Town to go out to bid, which back then came to \$31,000.00 Then the District asked Larry Cobb to go look at it and back then he said it was too big a job and he did not want to risk it as it was too dangerous. At least there is no asbestos there.

Councilwoman Annabi seconded for discussion. She asked why she had two (2) different amounts. Supervisor Oliverio said that they are two (2) different fees and had to be done separately. Supervisor Oliverio said that the ad has already been placed and will be open on December 28, 2016 at 2:00 PM. The home that is abandoned in Floradan Estates will be next.

RESOLUTION #R16-375

RESOLVED, that the Town attach a tax lien to the property at 192 Tanglewylde Road, Lake Peekskill, New York of \$3,188.20 in legal fees and \$2,337.50 in Engineer Fees leading to the demolition of the property.

Seconded by Councilwoman Annabi, unanimously carried.

HEARING TO DETERMINE THE AMOUNT OF PENALTY TO BE IMPOSED UPON
GENNADY VECHNYAK OF 12 LONG RIDGE TRAIL, PUTNAM VALLEY, NEW YORK.
THE VIOLATION TO BE MADE WHOLE AS SPECIFIED IN THE RULING BY THE
PUTNAM VALLEY ZONING BOARD OF APPEALS DATED OCTOBER 27, 2016
Presented by Councilwoman Whetsel

Supervisor Oliverio explained that the Zoning Board asked the Town Board to impose, lower or waive the civil penalty for Mr. Vechnyak. Mr. Vechnyak wrote a letter explaining his circumstances to the Town Board which Supervisor Oliverio said he read and understood why Mr. Vechnyak did what he did because his roof was collapsing, but then he added an entire second floor. He did have a permit in 2009 but never got a new one. Supervisor Oliverio said that from his letter Mr. Vechnyak admitted he had knowledge that he needed a permit and understood that he was wrong. He added that it is important the residents in Town follow the rules and regulations and it is not fair to those who do. The Zoning Board could make you tear down everything but they are allowing you to keep it as long as you fulfill the necessary requirements they gave you. You did violate the Town Code. The most we can charge you right now is \$500.00. It was then discussed with the Town Board.

Councilwoman Annabi read the letter he wrote and felt that he truly did not realize he had to get another permit and that he did not go above and beyond what he said in the original permit. You did not change anything that you originally asked for. She would like the fine waived or lowered.

Council people Whetsel, Luongo and Mackay were in favor of lowering the fine as was Supervisor Oliverio. Supervisor Oliverio said he thought \$100.00 was fair and Mr. Vechnyak needs to bring the fine to Town Hall before the end of the year.

RESOLUTION #R16-376

Maybe the LED street lights should be placed there to save money. There may be a grant for this. This is one of the four tenets we need to achieve.

Councilman Mackay said everyone should be trained to use it. Councilman Luongo said the Defibrillator is easy to use but people should also be CPR Certified because it doesn't go alone. It only works if it is a shockable rhythm. It should be a combination training. Supervisor Oliverio will check on this, because it was not his understanding.

RESOLVED that the Town Board authorize the Supervisor to purchase one (1) Heart Start FRX Defibrillator, wall mount, carry case, battery and pads in the amount of \$1,604.45 from the General Fund, this is State Bid pricing through Philips Healthcare.

Further resolve that the Town Board authorize the purchase of three (3) FRX Defibrillators and accessories in the amount of \$4,257.00 to be funded by the Parks and Recreation Department. Existing defibrillators that the Town owns are outdated. Pads and batteries will only be available to 2018. Councilman Mackay asked if we are ever going to be able to get relief for these people. Sam Oliverio said no because the Senator does not represent the District. Councilwoman Annabi said it is a catch -22 because Yorktown said these people should have attended their Town Board Meeting if they have a problem, but no one notifies anyone in Mill Ponds as to when their Town Board Meetings are. Supervisor Oliverio said he did bring Henry Boyd out who is an expert on water systems he said it would cost over \$350,000.00 to do the wells and they do not have that kind of money. It's a tough situation, and he worries about High Fields - at least they are close to the school. Councilwoman Whetsel said municipal water is expensive.

PUBLIC COMMENT

Arlene Rubinstein, a Trustee from the Putnam Valley Free Library spoke. She said that it has come to their attention that some people are confused about the change of hours the Library has advertised. Starting on December 1, 2016 the Library began closing on Sundays when previously it had been open for four (4) hours on Sundays. As with all business operations there are constant increasing challenges and expenses. Faced with fixing and replacing both the pedestrian and vehicle bridges and the increase in the minimum wage in 717, along with the failure of the 414 this is a matter of economic reality. We also have to pay more to belong to the Hudson Valley Library System, upgrade technologies and the budget from the Town also remains the same from 2016. This was done to save operational costs and show fiscal responsibility; we also found the library is used mostly Mondays – Saturdays. The Library remains open for 45 hours a week six (6) days a week as follows:

Monday, Thursday and Friday open 10AM - 5 PM Tuesday and Wednesday open 10 AM - 7 PM Saturdays open 10 AM - 4 PM

We are sorry if this causes anyone any inconvenience; but we must meet our vast expenses. All our permits are in place to do the work and the digging for the footings for the pedestrian bridge have already begun. In addition, the library's resources can be accessed 24-7 on line. All magazines are also available on line. We also have resurrected our "Friends of the Library" group who will be in charge of all fundraising and special projects. All volunteers are welcome please contact the library if you are interested.

Councilman Mackay said it's almost Christmas and Hanukkah, please don't forget to order your holiday dinner from Neise's Farm. He also stopped at Watson's which is the new Restaurant located at Oregon Corners. They will be open the week after Christmas and will do a little something on New Year's. Please support this new business – it will be family friendly and evenly priced.

Councilwoman Whetsel reminded everyone Jonathan Kruk will be at the Tompkins Corners Cultural Center on December 28th with his wonderful story telling. Please join us.

Councilman Luongo said Shawn Keeler puts in an unexplainable amount of time to keep these organizations running. He came up through the ranks, and there will be things we will miss about him. Thank you very much Shawn. Please make sure with this bad weather coming this weekend make sure you have the right tire and you remove all the snow off of your car. The snow that lies on top of your car causes a lot of problems, and don't leave a little hole in your windshield. Please take that extra minute or two.

Councilwoman Annabi thanked Supervisor Oliverio for his great first year. There were a lot of things that got done. Supervisor Oliverio agreed and thanked the Town Board as well.
