#### **DEPARTMENTAL REPORTS**

New Chief David Anderson reported on the Fire Department's month of December 2017 calls:

22 calls for the month - 401 man hours. Chief Anderson thanked his Firefighters for the great job they have done this year. There were two (2) fires which could have been very bad but they did a great job of keeping things under control.

Councilwoman Annabi also thanked the Fire Department for the great job they did with all the accidents that took place in the icy conditions that we had recently. Supervisor Oliverio also thanked the Highway Department for the great clean-up work they did during the same bad weather we experienced. They made sure that we were safe and did a superb job. He added that you should not put your snow back in the road. Think about your neighbors and our emergency vehicles. There are fines if you do that. Councilman Luongo said please clean your vehicle off. Take the extra time to do this it's for everyone's safety.

Councilman MacKay read the proclamation to Mr. Pugh. Councilman MacKay said that Billy is another example of the amazing kind of people who live in our Town. He has dedicated himself to make this Town a better place. Mr. Pugh thanked the Putnam Valley Parks and Recreation Commission and Staff and suggested that everyone should become a volunteer.

# **COUNTY LEGISLATOR REPORT**

County Legislator, Barbara Scuccimarra and County Legislator Bill Gouldman were unable to attend tonight's meeting.

#### PRESENTATION BY DISTRICT ATTORNEY ROBERT TENDY

Presented by Supervisor Oliverio

District Attorney Tendy also thanked Billy Pugh for his volunteer service and commitment to our Town. He also mentioned the sad news of the passing of resident Jeanne Gallinger. She was a positive force for good in our Town. District Attorney Tendy went on to say that is you are a hand gun owner in Putnam County there is a law that requires you to recertify your pistol permits. You may be unaware of this and think your permit is good for life. If you received your permit before January 15, 2013 you must recertify it by January 31, 2018. After this date your permit is technically void. Theoretically you will be in possession of illegal hand guns. You can recertify your permit on line and it doesn't cost anything. You have five (5) years from the date of issuance to recertify.

He then spoke about the addiction problem that is now part of his daily job. Overdoses are drastically on the rise. It involves people of all ages and demographics. If you have an addiction of any sort tell people about so you can get help. Don't try to hide it there is no shame in it. We need to change the mindset. This is a sickness and you need to go to a Doctor just like any other disease you may have. Anthony Arrien will put the Putnam County Resource List on the scroll and District Attorney Tendy will leave some at the Town Hall so people will know where to go to get help. It will go on the Town's website as well. You can also contact District Attorney Tendy's office at 845-808-1050. We do try to get help for people who are involved in drugs in any way. Nobody wants to be an addict and we want to help them. Additionally, if you see something going on in your neighborhood call us. We will quietly do an investigation and those often lead to a real good arrest. You don't have to give us your name. If you are an immigrant and you are the victim of a crime please call we will not ask your immigration status. We only want to catch the people/person victimizing you.

## SET DATE FOR VETERAN'S EXEMPTION PUBLIC HEARING

Supervisor Oliverio said this will just be a discussion because we will not need a Public Hearing. We don't need a Resolution to accept this. We either adopt this or we don't as explained to him by our Assessor. The State has given us an option to either say Cold War Veterans will receive the same exemptions as those who served during war time. There are two (2) sides to this issue so I would like to set the date of February 7, 2018 and have this as the first thing on our agenda for discussion. Every time we do an exemption, those who do not get the exemption pay for it in their taxes. Also, it is equitable? As a veteran I never saw battle, so do I deserve what they deserve? If you never fought during a conflict do you warrant the same benefits that those who fought do? There is a deadline on this so we need to make a decision.

Supervisor Oliverio said the State has a huge deficit of 64 billion dollars so we cannot count on them for any money including our CHIPS money. We have to provide to our residents what we need not what we want. Last year Town Day cost us \$12,000.00 so we may not be able to do that this year without charging. District Attorney Tendy said he thinks Town Day is a necessity to show the Town we are all neighbors. Maybe we can raise the money in different ways. People always say that this is the best event in the County.
