### AUTHORIZE SUPERVISOR TO SIGN LEASE CONTRACT WITH THE NYC ARCHDIOCESE CONCERNING THE USE OF THE YMCA CAMP AS A SUMMER CAMP

Supervisor Oliverio asked Parks and Recreation Director Frank DiMarco to address the Town Board and the residents. Mr. DiMarco said the reason he came to the meeting was to explain what is going on with the day camp contract. He continued by saying we have tried to purchase this camp at least a dozen times over the last 13 years. This is a two (2) year discounted contract with an option to purchase. The discount is \$10,000.00 less per year but for this I have agreed to do some off season maintenance during the year. The purchase price is 1.9 million dollars. Mr. DiMarco will come back next week with some solid numbers. There is a lot of potential here - there is a pool on premises. The property is 161 acres. Supervisor Oliverio said you are asking for a referendum – much like the Rec. Center. Mr. DiMarco said ves and added that he would be able to run many programs at this site. Create ball fields and work in conjunction with the school district to hold various events. Councilperson Whetsel mentioned that in September of this year the bond on the park will be paid off. That money may make it a zero cost to the taxpayers. There are also many indoor facilities on premises there as well.
