**RESOLVED** that the Town Board amend Resolution #R18-210 authorize the Town Supervisor to sign the contract with Kohler Roman LLC., in the amount of \$14,500.00 to oversee the purchase and installation of a generator that will provide power to both the Town Hall and the Parks and Recreation Buildings. The original Resolution was approved for \$14,000.00; the proposal amount is \$14,500.00.

#### DISCUSSION ON COUNTY WIDE TAXI AND LIMO LAW

Presented by Supervisor Oliverio

Supervisor Oliverio said we received a letter from Neal Sullivan who is the Chairman of the Rules, Enactments, & Intergovernmental Relations Committee in Putnam County, which Supervisor Oliverio put in each Town Board Members packet. The letter is asking if the Town wants to support a taxi and limousine ordinance within the County. Supervisor Oliverio feels the problem right now is that our people (who are licensed in Putnam County), go down to Westchester they are not allowed to participate in taxi duties over there. There is no reciprocity even though taxis from Westchester cross over our border all the time.

What the County would like to do is to formerly set up a Taxi and Limousine Commission to oversee this, to provide reciprocity, and to be able to tax the service. Councilperson Annabi asked if this will affect the Uber drivers we have in this area? Supervisor Oliverio responded yes, as far as I know they would put it all under one (1) heading as taxi service; but it does depend on what the other Towns say. Councilperson Annabi continued by saying here we don't have transportation as it is. We really have to rely on the taxi service offered from Peekskill - which is a monetary hardship for our residents to begin with. We don't want to put a further financial burden on them with an additional tax. The Town Board had a discussion as to whether this would be beneficial to our residents. Attorney Florence said the good part of this would be that someone will oversee the conditions of the cars to make sure they are safe and clean. It is an expense because there will now be people making sure the drivers are properly licensed and the cars have been inspected. On the other side it is an expense and in urban areas this is a police function. Councilperson Mackay said the majority of the taxis in Putnam Valley that he has seen are from Peekskill. In Peekskill the taxis are regulated and licensed so we are getting that regulation anyway. Councilperson Luongo said maybe this could be another avenue for jobs. He does not see a down side. Council Florence said if you create this Commission you will pay for it one (1) way or another. Right now you are getting the benefit of it without cost to our residents using taxis from Peekskill where this already exists. Supervisor Oliverio said and of course someone will have to be in charge of this Commission - this is another expense. Councilperson Annabi said this will be an additional burden on our residents with the additional tax. We can always join the Commission later if we suddenly get an influx of taxis. Supervisor Oliverio concluded that for now we will take a "sit back and watch position".

### APPROVE EXPENDITURES TO HOLD PERMISSIVE REFERENDUM ON THE LEASE OF PROPERTY TO HOMELAND TOWERS

## **RESOLUTION # R18-230**

**RESOLVED** that the Town Board authorize the Supervisor to approve the expenditures need to run the Permissive Referendum on lease of property behind the Highway Garage to Homeland Towers. Seconded by Councilperson Mackay, unanimously carried.

Supervisor Oliverio would like to ask the Town Boards permission to pay the lifeguards and monitors past the current policy of three (3) days of the beaches being closed due to an algae bloom or rain. He said these are young people who have expended a lot of time, energy and expense to become lifeguards and are ready to work. They have not made that money back because they have been prevented from working. They should be paid the salary that we have told them they would be paid. The money is already in the District budget for this purpose. They are kids who are trying to save for college and other things young people need money for. Some are put on the beaches but they can't go near the water and it's tough. Councilperson Annabi said the lifeguards can go to the beaches and make sure people don't go into the water. She also feels it is up to the Districts if they want to pay them or not. Supervisor Oliverio said the Districts have already agreed to pay them when they put that money into their budgets.

Councilperson Mackay says the Lifeguard course is a rigorous and expensive class to take but is it the Districts money to spend. Supervisor Oliverio added that we have the District Budget Meetings where this money is agreed upon. The three (3) days is an unwritten policy, and the fear is that these people will get a job elsewhere, and when the beaches reopen there will be no one left to work them. Councilperson Luongo said if the District is okay with this it's okay with him. We cannot tell how long this will go on. We asked them to work for us and we have entered into a quasi-legal contract with them. Supervisor Oliverio said we **will** pay the monitors and lifeguards no matter how long the beaches are closed. No Resolution is needed as this is an unwritten policy.

Councilperson Annabi said that there have been a couple of accidents with commercial trucks on Tinker Hill. She reached out to Google Maps, Tom Tom, Mapquest etc. and asked them to remove Tinker Hill as a commercial route for trucks - not for individual cars. Map Quest and Google Maps have responded in the positive - the County will be doing what they can to reinforce the policy of no commercial trucks on Tinker Hill. Councilperson Annabi asked Attorney Florence if the Town could impose a fine on trucks using Tinker Hill when there is a sign that says "Local Use Only"? Attorney Florence said yes, but first we have to categorize it for residential or automobile passage only - no commercial trucks except for local deliveries. Secondly, if you don't adhere to this there will be a fine of "X" dollars. The dollar amount will have to be determined. Councilperson Luongo said another problem when addressing the commercial wi-fi direction companies is that many truckers don't use the commercial apps. for directions because it costs more than the one (1) for cars. The Town Board had a discussion on this issue. Councilperson Mackay said you can make all the laws and fines you want but you need someone to stop them and issue the fines. The Police do a great job, but they can't be everywhere.

Attorney Florence said if we alert the Sheriff's Department to our local ordinance about the dangers of Tinker Hill we might have them be mindful to stop the trucks and issue a violation. Attorney Florence said we will add this to our vehicle traffic section so the fine money comes back to us. We will need a Public Hearing.

Supervisor Oliverio reminded the community that the vote on the cell tower is on August 21<sup>st</sup> from noon to eight o'clock PM in the Town Hall Court Room. We do have absentee ballots. It is an important vote – your vote is your voice.

Councilwoman Annabi said Town Day is for both not-for –profit and for-profit businesses. Come down and get your applications in. Our electric is very limited.

We have classic cars coming; the "Rat Pack" will be entertaining us, and Karaoke. Please don't miss out. The parking is only at the Elementary School unless you have a handicap pass or are a vendor. There will be shuttle buses from the school. To be a vendor you can call Beverly Kelly at 845-526-2121, or email Councilperson Jackie Annabi at <u>annabipvtb@putnamvalley.com</u>. She also thanked the Fire Police, Tompkins Bank, Hudson Valley Gateway etc. for helping us out.

Councilperson Luongo asked where we stand with our shuttle. Supervisor Oliverio said he called Vinny Tamagna today - no route has been changed or cancelled. Please be patient the buses can't park at the train station. Councilperson Mackay explained how the traffic patterns work at the Peekskill Train Station. The bus may have to go around the block because there is chaos when the trains come in. Supervisor Oliverio said Mr. Tamagna does want to discuss our Towns extremely low ridership on some of the runs. Councilman Luongo reminded everyone that we do have a shuttle that leaves from the Town Park five (5) times a day and goes to the Peekskill Train Station, then returns you to the park from the train in the evening. Please see our website for the schedule. No changes have been made and there are still permits available. Councilperson Mackay said this has been advertised everywhere it can be placed since the inception. There is no other place to put it out. Supervisor Oliverio said if the bus is not there call the number that is on the website and they will tell you the location of the bus.

Next week we will hear from the young man who wants to put up a sign for a turtle crossing; and also LOSAP, so the Fire Services can collect the correct points for their retirement.

Supervisor Oliverio moved to close the meeting and hold an Executive Session for the purpose of discussing a personnel and litigation matter. No further business will be conducted afterward. The meeting was closed at 7:49 PM.
