Commercial Traffic on Tinker Hill Road

Whereas Tinker Hill Road connects two (2) main travelways, Oscawana Lake Road and Peekskill Hollow Road; in the Town of Putnam Valley and;

Whereas the zoning district is for residential development and;

Whereas the intersection at Oscawana Lake Road and Tinker Hill Road has very limited sight distance for vehicular traffic and;

Whereas Tinker Hill Road has severe drop in elevation for its entire length and;

Whereas Tinker Hill Road has curves of varying radii as the elevation drops for vehicular traffic traveling from North to South and;

Whereas the road elevation does not have a level intersecting construction providing an appropriate level space for vehicles on Tinker Hill Road to brake approaching Peekskill Hollow Road and;

Whereas the minimum speed limit the Town is authorized to enact is not adequate to provide safe travel from north at Oscawana Lake Road to south to Peekskill Hollow Road.

Now Therefore, It is determined that through commercial traffic is not authorized to traverse Tinker Hill Road if it has either a tare weight of in excess of 6000 lbs. or more than six (6) wheels. The exception is commercial vehicles providing for a local delivery at any premises on the aforesaid Tinker Hill Road.

This Town Board agrees to enact a local law prohibiting commercial through traffic for vehicles of more than 6000 lbs. tare weight of more than six (6) wheels. Fines for violators of this local law are: \$1,000.00 for the first violation and \$2,000.00 for the 2nd or more violations.

The local law shall read as follows: §122-17.1(c)

Be it enacted:

The Town of Putnam Valley prohibits through commercial traffic on Tinker Hill Road. Commercial Vehicles with a tare weight in excess of 6000 pounds or more than six (6) wheels is prohibited from traveling on Tinker Hill Road; with the exception of deliveries of addresses on Tinker Hill Road.

§ (d) Fines for first offense shall be \$1,000.00.

Fine for second or more offenses shall be \$2,000.00.

Re: REQUEST TO WAIVE WETLAND PERMIT WAIVER FEES

I formally request that the Town Board waive the fees for a Town of Putnam Valley wetland permit waiver to transplant pickerel weed from an area upstream of the grass carp barrier (20 West Shore Rd.) to other areas around Roaring Brook Lake.

The proposed locations are:
The base of Spur Beach peninsula
Taconic parkway storm water inlets
And both sides of the Park Beach peninsula

Details on this project are attached.

RBL Pickerel Weed Transplant Project

The community of Roaring Brook Lake and the Town of Putnam Valley seeks permission to transplant a number of pickerel weed (*Pondetaria cordata*). This ~ 2 yard stand of emergent plants has been growing in size, located upstream in the from the grass carp barrier. During the fall when these plants die off, the decaying, floating fragments clog up the barrier and contribute to streambank erosion as the water level in the stream rises. This can negatively impact the structural integrity of the streambanks and the paved road which it runs beneath through 3 large culverts.

In addition, these photographs were used to confirm this species as *P. cordata* by Stephanie June, Research Scientist in the Division of Water, Lake Monitoring and Assessment.

Rather than simply cutting the stalks and disposing of them, we would like to transplant them into some of the shallow coves since the lake is lacking in both abundance and diversity of emergent shoreline plants. The proposed sites all feature substantial unconsolidated sediment where HABs often collect or appear. We intend to leave a few plants in place to serve as a bank for future transplanting as well, and all harvesting will be done by hand and the roots cleansed of sediment prior to transfer. No excavating will be performed.

The proposed locations are owned by the Roaring Brook Lake Improvement District and are located as follows:

- Both sides of the base of the Spur Beach peninsula (41.10-1-7)
- Taconic State Parkway storm water inlet at 41.-2-7 (between 41.9-1.17 and 41.9-1-3 and 41.9-1-4)
- Taconic State Parkway storm water inlet at 41.-2-7 (adjacent to 41.10-1-28)
- Both sides of the base of the Park Beach peninsula 41.6-2-13)


