**PUBLIC HEARING ON A PROPOSED LOCAL LAW WHICH WILL ALLOW AND  
REGULATE FOOD TRUCKS IN THE TOWN OF PUTNAM VALLEY**

Presented by Supervisor Oliverio

The Town Board met and Resident Kimberly Tyra co-owner of the Beastro food truck that is parked in Lake Peekskill thanked the Town Board for allowing this to happen. Supervisor Oliverio said that we will be allowing food trucks in the Town of Putnam Valley with the locations being determined by the Board. Once voted on this will become effective right away. Councilperson Mackay asked if the Supervisor was okay with the amount of the fees. Councilperson Mackay thinks they may be too low. Town Clerk Howard said there is already a \$500.00 fee in place which covers a vehicle under the "peddler's license" law. Councilperson Mackay added that in order to determine a good location for a food truck a traffic study will be needed for that specific spot. Supervisor Oliverio said we already have one (1) location preapproved by the County which is near the end of Peekskill Hollow Road where the overpass for the Taconic is located. Supervisor Oliverio added that if you place a food truck on private property a site plan is mandatory. Councilperson Mackay said there needs to be a certain distance between a food truck and a brick and mortar store. Otherwise that is not fair. There are some things that need to be ironed out.

Councilperson Luongo said in the near future there will be a lot of long term work being done near Roaring Brook on the overpass and there are no delis etc. in the area. So that would be a great place for a food truck. Supervisor Oliverio said some things can be added or changed as needed but the basic law is good. Ms. Tyra said the fee charged should be comparable to the surrounding towns; and we sell different meals than what the brick and mortars sell. We also have a letter from the owners of Lizzie's that they have no problem if we stay across the street from them. Supervisor Oliverio said the place you are now would be great for you if you can stay there. He added that this law will be in place by January 1<sup>st</sup>. Councilperson Mackay said that they should check what the other Towns are charging.

As there was no other public comment, Supervisor Oliverio moved to close the Public Hearing at 6:11 PM.

It was seconded by Councilperson Luongo and was unanimously carried.

#### **PUBLIC HEARING ON A LOCAL LAW REGARDING AN UNFUNDED STATE MANDATED FIRE FIGHTER CANCER LAW**

Presented by Councilperson Luongo

Councilperson Luongo said that unfortunately there are several types of cancers predominately seen in Firefighters. Due to this, the State passed a bill which mandates that Towns provide insurance to the Firefighters to cover them if they get sick with these kinds of cancers. There is a criterion that needs to be met before they are covered. Firefighters are required to get a physical every year and use the correct protective equipment – this is the individual's responsibility. The Town's responsibility is to make sure they are covered by paying for the coverage. Supervisor Oliverio said the State made this another unfunded mandate. The insurance is for active firefighters only and costs about \$150.00 per person. Councilperson Luongo said there are numerous conditions that apply and Supervisor Oliverio said it is a complicated issue and we still need some answers from the State. The State does not want to pay for this but the amount of cancers that firefighters have gotten since 9-11 is astronomical. Councilperson Luongo said this law comes into effect 1-1-2019 and we must adopt this. Supervisor Oliverio said as this is mandated we did not really have to hold a Public Hearing; but we wanted everyone to know what is going on since it affects tax dollars – but there is no choice.

As there was no other public comment, Supervisor Oliverio moved to close the Public Hearing at 6:17 PM.

It was seconded by Councilperson Mackay and was unanimously carried.

**PUBLIC HEARING ON A PROPOSED LAW TO ADOPT THE NATURAL RESOURCES INVENTORY**

Supervisor Oliverio said we did have a Public Hearing set on adopting the Natural Resources Inventory but for now we are going to hold off on that and remove it from the agenda.

**RESOLVED** that the Public Hearing on a proposed law to adopt the Natural Resources Inventory to expressly integrate use of such inventory into all land use decision making within the Town of Putnam Valley be postponed until a further date.

It was seconded by Councilperson Mackay and was unanimously carried.

Councilperson Whetsel explained the postponement by saying that there is going to be corresponding documents to the different mapping that has been created, and they are still being written and finished so we didn't want to have a Public Hearing and adoption until everything is able to be viewed by the public.
