WHEREAS, the Town Board recognizes that these other world beings are generally recidivists and cannot be reformed no matter how much mischief they cause and notwithstanding the punishment that is prescribed; and

WHEREAS, it would be to no avail to provide for corporal or other punishments since fairies, spirits, wee folk, leprechauns and goblins of the hob type are incorrigible; and





WHAT WE PROPOSE TO DO

Option I

We will conduct a topographic survey of the entire length of Horton Hollow Road. The area covered will begin at the intersection of Horton Hollow Road and Canopus Hollow Road and run southwesterly to the intersection with Cimarron Road, a total of approximately 4,600 feet. Additional areas approximately 100 feet along each intersecting road, east and west of each intersection, will be included. The mapping will cover an area approximately 110 feet wide, generally 30' either side of the right-of-way of Horton Hollow Road.

The survey will be prepared using a combination of photogrammetric mapping and classical surveying methods. The photogrammetric mapping will be based on new aerial photography, captured specifically for this project. The mapping will be augmented using classical methods to obtain those items that must be precisely located or are too small to see in the photographs, such as the mailboxes, markers, cross culverts, etc.

The survey will be compiled and mapped at a scale of I-inch equals 30 feet (I" =30') with a two-foot contour interval and sufficient spot elevations to define those areas of the route where contours do not provide sufficient definition. The location of physical features within the survey limit will be shown, including but not limited to, buildings and structures, road pavements, driveways, walks, rock outcrops, above grade utilities, surface evidence of below grade utilities, signs and mailboxes.

Right-of-way lines and property lines will be shown based on existing mapping, surveys and deeds in our possession or that are available to us from the Putnam County Clerk's Office. Property owners will be identified from the current tax assessment rolls.

Not included in this proposal is the delineation, location or mapping of any freshwater wetlands that may exist within the survey limits.

The survey will be referenced to the NYS Plane Coordinate System (NAD83) and the North American Vertical Datum of 1988 (NAVD88).

We will prepare our map using AutoCAD release 2004 or higher. Maps will be delivered as hard copy prints, and in .pdf and .dwg formats.

Option 2

This option includes the Topographic Survey noted in Option I above together with the location of all trees 6" D.B.H and over within the mapping limit. Trees will be identified by their common name, but will not be tagged.

<u>FEE</u>

The fees we will require to complete this work are shown in the following table.

Option	Fee
I – Topographic Survey	\$21,350.00
2 -Topographic Survey with Trees	\$26,350.00

These are fixed, lump sum fees which reflect prevailing wage rates for field personnel as required by the NYS Dept. of Labor for "public work".

SCHEDULE

We note that completion of the new aerial photography is dependent on weather conditions and the presence of snow cover. Once ordered, the photography will be captured on the next day when flying conditions are suitable and snow cover is absent. Given that we have just had 6" of snow fall in the area of the mapping, it may be 4-6 weeks before the flight is completed and the photography is available. However, once the photography is captured, we expect the final mapping will be completed in an additional 15-20 business days, regardless of which option is chosen.

ADDITIONAL SERVICES

Additional services are any services requested by you that are not offered in this proposal. If additional work is requested, the fee will be calculated using our current hourly rates. We will be pleased to provide an estimate of our fee for any additional work prior to it being authorized. We have attached our rate schedule.

INVOICING & PAYMENT

You will be invoiced for our entire fee when the survey is completed. Payment is due when the bill is rendered. Payment is expected within 30 days. If the account ages more than 30 days, a service charge of 1.25% per month (15% per annum) will be charged.
