PUBLIC HEARING ON MARIJUANA MORITORIUM

Presented by Supervisor Oliverio

Supervisor Oliverio moved to open the Public Hearing at 6:02 pm.

Marijuana Moratorium was read by Deputy Town Clerk, Kimberly McKeown as follows:

Marijuana Moratorium

Resolved that the Town of Putnam Valley will begin a 1 year moratorium on the establishment and or stocking of any store, shop, kiosk and or business structure that will sell any marijuana products and or their related paraphernalia retail and or wholesale within the Town. This moratorium will provide the Town time to study the appropriate location for this type of business due to the health concerns this product may cause based upon the psycho-emotional effects that these products provide. The moratorium will begin immediately and end on April 17th, 2020. The possibility of an extension of this moratorium will be considered as April 17th, 2020 approaches. This Marijuana Moratorium will be all inclusive and will include stores, shops, business structures and kiosks that might also already be established within the Town.

Supervisor Oliverio asks for Public Comment, of which there was none.

Supervisor Oliverio thanked Councilperson Mackay for introducing this measure, he also commented that the State did not legalize marijuana but he feels legalization is on the horizon. Supervisor Oliverio agrees that this moratorium is a good thing to do.

Councilperson Luongo spoke and said he agrees with the Supervisor. Councilperson Luongo also stated that the way this was presented was if legalization had passed it would have been thrown right into our laps and we would have had nothing to say about it, so this buys us some time, to figure things out, and who knows what we may find.

Supervisor Oliverio mentioned that since legalization car accidents in the State of Colorado are way up.

Councilperson Annabi spoke and wanted to clarify that this does not affect medical marijuana, only recreational. Medical marijuana is distributed through dispensaries and there are no dispensaries in Putnam County. This moratorium will not stop a dispensary from coming into the Town of Putnam Valley, should that ever become an issue. Supervisor Oliverio stated, yes, only if a dispensary is licensed by the State. Councilperson Annabi continued to say this is only for recreational marijuana like the Juul. We are not going to allow the sale of recreational marijuana in The Town of Putnam Valley, if it does become legal by our State. She went on to add that other States thought that by legalizing marijuana there would be an increase in sales, the sales are not even close to what their projection was, this is a good thing. They expected hundreds of thousands of dollars in sales, whether it is Connecticut or Colorado when they legalized, and that did not come to pass. Councilperson Annabi also mentioned that car accidents are more violent when happening under the influence. We have laws that whether it is alcohol or drugs, driving under the influence of either is illegal.

Councilperson Mackay then began by saying he would like to thank everyone for their support of this moratorium. He also asked that if it is acceptable to the Board, he would like to invite anyone watching who cares to send a comment, to do so, and their comments will be included in the record. Supervisor Oliverio agreed. Councilperson Mackey went on to add that the marijuana of the 1960's was 6-10% TCH, the recreational marijuana of today is 90% TCH. Councilperson Mackay said he attended a meeting held by the County Sheriff and the County Health Department and that is where he got these statistics. The other thing he would like to add is that it has been reported in the NY Times and was also talked about at the County meeting was the increase in Emergency Room visits. One reason may be that edible recreational marijuana is big in Colorado. When in inhaled or smoked marijuana enters your bloodstream, quickly. Not so, with the edibles which have to pass through your intestines and take longer for the "high".

The theory is that people eat more and more edibles to feel the effect, and when it hits them all at once, they are in a psychotic state and in need an emergency room. Councilperson Mackay thanked everyone again, and stated he hopes the County will also pursue this. Supervisor Oliverio asked Legislator Gouldman, who was in the audience, if the County had any plans regarding this matter. Legislator Gouldman said the County has the intention of looking at these issues.

Supervisor Oliverio said the Town of Putnam Valley is adopting this moratorium and he hopes other towns will follow.

Supervisor Oliverio moved to close the Public Hearing at 6:08 pm, but not before reminding everyone that Public Comment on this matter would remain open until next week. Councilperson Luongo thought we should be more specific about that date and time of Public Comment closing. Supervisor Oliverio agreed and stated that Public Comment on the Marijuana Moratorium will close on Wednesday, April 17, 2019 at the close of business or 4:00 pm, he added that public comments may be emailed or brought into Town Hall in person.

It was seconded by Councilperson Mackay, unanimously carried.
