Dear Supervisor Oliverio:

As the Putnam County Legislative representative to the Putnam County Emergency Services Safety Advisory Board (ESSAB), I was in attendance at the April 24, 2019 Meeting. After the meeting and being part of the discussion, I agreed to bring the following matter in the form of a very informal proposal to you and the Board Members.

The ESSAB would like each Town/Village Board to give consideration to the following: A "False Alarm Penalty Fee". There is a financial burden to our County's emergency response teams resulting from False Alarms. The obvious is of grave concern; non-emergency incidents that the emergency responders go to make them unavailable to respond to legitimate emergency calls. These False Alarms are taxing the emergency responders and do generate a cost to each of the agencies.


The ESSAB is requesting, for the sake of sending a message of uniformity and support, to address this problem throughout the County each Town/Village institute the following financial penalty schedule:

<u>*Annual - False Alarms Penalty Fee Schedule:</u>	
1 st time	No Charge
2 nd time	\$50.00
3 rd time	\$100.00
4 th time	\$200.00, plus \$100 increments for each offense thereafter
5 th time	\$300.00, et al

**January 1st of each year every residence incident report related to False Alarms resets to zero*

Also the ESSAB is requesting that the current Fire Alarm Permit Application require that the applicant include the following detailed information: Property Owner's Insurance Information, including the company name, company address and company phone number. The permit should also have language indicating that the insurance company will be notified if the alarm system fails to operate properly. Respectfully, I request after you and your Board Members have given consideration to this proposal, kindly provide me with your feedback. Thank you for your attention to this matter.
