AUTHORIZE SUPERVISOR TO ENTER INTO AN AGREEMENT WITH JOHN M. ZARCONE, JR, ESQ., ACTING ON BEHALF OF BROOKFALLS COTTAGES, INC., TO DRAFT AND EXECUTE AN AGREEMENT WITH THE TOWN OF PUTNAM VALLEY OUTLINING THE TERMS OF USAGE OF A CERTAIN BRIDGE for a fee of \$1,500.00:

RESOLVED, that the Town Board authorizes the Town Supervisor to contract with John M. Zarcone, Jr., Esq., acting on behalf of Brookfalls Cottages, Inc., to draft an agreement outlining the terms of use of a certain bridge over the Peekskill Hollow Brook adjacent to Brookfalls Road and Brookfalls Court to resolve any outstanding issues. For this service, the Town agrees to pay \$1,500.00.



Maintenance Agreement

BETWEEN **Brookfalls Cottages**, **Inc.**, a New York corporation, by William Venezia, President, with an address of Brookfalls Road, Putnam Valley, New York 10579, and **Town of Putnam Valley** (the "**Town**"), a municipal corporation with offices at 265 Oscawana Lake Road, Putnam Valley, New York 10579

WHEREAS the Brookfalls Cottages, Inc. is the owner of a certain bridge over the Peekskill Hollow Brook adjacent to Brookfalls Road and Brookfalls Court; and

WHEREAS the Town has access and use of the bridge owned by Brookfalls Cottages, Inc. and wishes to set out its rights and obligations concerning its use for a term certain; and

WHERÉAS the bridge is presently a part of the sole access to Town property beyond the bridge and private access road;

NOW THEREFORE for good and valuable consideration to each party the parties agree:

- (1) That the Brookfalls Cottages, Inc. grants and release to the Town of Putnam Valley, its employees, agents, guests and residents shall continue to have free and unobstructed access across the bridge and road access to the adjacent Town of Putnam Valley property; and
- (2) The owner of the bridge, Brookfalls Cottage, Inc., a New York corporation, shall continue its right to authorize third parties to have access to properties they own for which the bridge provides the sole access; and
- (3) In consideration of the above the Town of Putnam Valley agrees to insure against all liability claims related to its use of the bridge. Further, the Town of Putnam Valley shall agree to maintain the structure, and restructure as required and repair which includes the bridge surface; and
- (4) This agreement shall be in effect for the 99 years commencing upon execution of this agreement pursuant to its terms; and
- (5) The "WHEREAS" clauses set forth above are included in this agreement; and
- (6) This agreement shall be filed with the Putnam County Clerk's Office of Land Records; and

- (7) That this agreement is a covenant running with the land. The contents of which may be modified or changed but only in writing and signed by all parties; and
- (8) This agreement is revocable by the Town of Putnam Valley upon six (6) months notice to the bridge ownership, which is Brookfield Cottages, Inc., at present.
