Councilperson Mackay said he apologizes but he has to leave the meeting at 7:00 PM for a necessary doctor's appointment.

PRESENTATION BY BOARD OF ELECTIONS COMMISSIONERS CROFT AND SCANNAPIECO

Presented by Supervisor Oliverio

Commissioner Croft said this year for the first time New York will have early voting which begins on October 26th and runs through November 3rd. The only site where this will take place is at the Putnam County Board of Elections in Carmel. Ms. Croft handed out schedules to everyone in the audience, and left some on the display table in the hallway. You can also get the information on their website which is putnamboe.com. They will be using electronic pole books (known as e-poll books). These will be used for early voting as well as on Election Day. There will only be a sign in table where you will be asked for your name and address. The e-poll books are being used to make sure people do not try to vote twice. If you have early voted the e-poll book will say that. If someone does come in on Election Day and the book says you voted, but you insist that you didn't – you can still vote by affidavit ballot – no one will be disenfranchised. Commissioner Scannapieco added that if this does happen they will check their records later and if a person had indeed voted already their affidavit will not count. Commissioner Croft said you can still vote by absentee ballot but she encourages everyone to use early voting instead. If you vote early your vote cannot be challenged but an absentee ballot can be challenged. Commissioner Scannapieco said if you get an absentee ballot and are actually in Putnam County on Election Day you are supposed to vote in person.

Council Florence said if you are new resident to the Town but are registered in another county what do you have to do. Commissioner Croft said you should notify the Board of Elections before October 16th which is the cut-off date. Your registration now follows you from County to County but there are still some requirements. You would have to vote by affidavit.

Councilperson Whetsel asked how do you know that the person who is voting is who they say they are. Commissioner Croft said it works the same way as before, the signatures are still checked to make sure they look similar. If there is a problem and the Wi-Fi goes down the e-poll books will still be able to talk to each other in the polling site.

Supervisor Oliverio asked if next year there could be more than one (1) early polling place. The Commissioners both agreed that maybe there could be one (1) or (2) more but the cost might make it prohibitive. If we do have a second site next year we would need more polling machines. Commissioner Croft said they did receive a grant in the amount of \$117,000.00 which did pay for the new e-poll books. Commissioner Scannapieco said that even with the addition of early voting – it does not increase the amount of people who come out and vote. It will cut down on the amount of people that will have to wait on line on Election Day though.

Councilperson Luongo said the hours for early voting are good and we will get the information out on Channel 20 and on our website.

DEPARTMENTAL REPORTS:

Presented by Councilperson Annabi:

Putnam Valley Historical Society Director Gretchen Weiglein said on Saturday we had a terrific turnout for the lecture that was held on Israel Putnam and how he influenced Putnam Valley and the surrounding areas. We will be at Town Day and will have some giveaways. We will be running a tour of Fort Montgomery on October 12th – more information to follow. Our annual meeting is being held on Sunday October 20th from 1-4 PM at the Ambulance Corp building. Every year we try to do something different to bring people in. This year we will be recreating the first televised Presidential Debate between Richard Nixon and John F. Kennedy. Please join us – the cost is \$45.00 per person with a delicious dinner included. Sunday October 27th we are having two (2) Halloween events at the Museum. During the day there will be a mini pumpkin hunt and crafts for children and in the evening the Museum will be set up as a haunted house.

Director of the Putnam Valley Free Library Dede Farabaugh came to the podium and began by saying that there are a bunch of programs that will be happening in the next week or so. Next Tuesday is "national voter registration day and you will be able to come to the library and register to vote from 5-7 PM. This event being run in conjunction with the League of Women Voters - there will be free pizza! Tonight we will be watching "The Sun is Also a Star", and reading the book. Next month we will be reading and watching Mary Shelley's Frankenstein. Thursday is National "Talk like a Pirate Day" so on Saturday we will be celebrating with a Pirate Party. Next week on Tuesday evening we are offering mah jong at 2:00 PM and our yoga program at 5:30 PM. At 7:00 PM there is a lecture on autumn detox and diet. The library has a proposition on the ballot this November 5th which is called the 414. The 414 is the section of New York State Education Law which allows a Public or Association Library to put up their annual budget for public vote. We are having our Annual Meeting of the Board of Trustees on October 7th where they will discuss the annual state of the library, and the 414 with actual numbers and facts. There will also be information on the 414 in the coming month on the website. Ms. Farabaugh added that as library employees they are not allowed to advocate for or offer opinions one (1) way or another - we just offer facts. There are a lot of questions about the 414 and we hope to offer answers. You can also become a Library Trustee if you are interested. Please come by and ask how you can do that.

Assessor Sheryl Luongo made a presentation and shared a banner she had made which honors individual Putnam Valley veterans and active military service members. She said the banners are 24" x 48" and will be placed in brackets on telephone poles in Town on Peekskill Hollow Road and Oscawana Lake Road. For this to happen NYSE&G has to come out and check the integrity of each of the poles we want to use.

So far there have been 36 poles identified. These banners will be up between Memorial Day and Veteran's Day. There are not really a lot of poles available to use due to their condition and where they are placed on the road. In addition, she would like to group at least three (3) of them in a row. Councilperson Luongo said a lot of the poles are covered in or covered by a lot of vegetation. If anybody is interested in purchasing a banner there is a website you can go to - militarytributebanners.org. You would go to the site and click on current programs – you will find an order form there. At this time she is not taking money as she does not know how many people will be interested in doing this. If there are more people interested than she has telephone poles there will have to be a lottery system. The cost of the banner will be about \$140.00 and the sponsor of the banners name will also be printed on the banner. Supervisor Oliverio said that if we do this we will be the first ones in the County to honor our Veteran's in this way. Resident Patty Villanova asked if this will be a permanent program and who will be putting up the banners? Ms. Luongo said Highway Superintendent Larry Cobb offered to install the brackets on the telephone poles. On Veteran's Day the banner will be handed back to the family that purchased them - the bracket will remain on the pole so the next banner will be able to be placed there. There will be no cost to the taxpayer as the banners and brackets are being paid for by whoever purchased it. A photo of the person needs to be uploaded in order to create the banner.

Highway Superintendent Larry Cobb and Vice Chairman of the Putnam County Traffic Safety Board Ron Cummings reported. Supervisor Oliverio asked the two (2) men to speak about the incident that occurred on Tinker Hill Road. Mr. Cummings said Putnam County's Traffic Safety Board was responsible for setting up the first "alternate route" signs in the Town and County (this program is now throughout the state) as well as establishing the program entitled "Keeping Seniors Mobile." This program consists of having a Judge or District Attorney go to Senior Centers to help them continue to drive. They have also gone to every School District and have spoken to every school bus driver about the safety of children getting onto and off the bus. As far as Tinker Hill there have been many complaints so we have been working with the New York State Department of Transportation on how to change the laws so that Tinker Hill can be made a safer place. There was also a problem on Canopus Hill where a bus was stuck for four (4) hours because the road is very narrow. Highway Superintendent Cobb said big red signs have now been posted on both the top and bottom of Tinker Hill reading "NO TRUCKS". That road is dangerous on even a bright and sunny day. Local deliveries will still be allowed on that road. We are still working to get Tinker Hill off of the GPS truck route. Supervisor Oliverio said he's been asked why Tinker Hill can't be made a one-way road up the hill. Superintendent Cobb responded how are you going to put out 5000 people who live on the north end of Lake Oscawana and use it every day to go to the Taconic and make them go all the way around? If you do that you will be causing a lot of people a lot of trouble. This is a work in progress and the signs are large and bright so truck drivers can't miss them. Councilperson Luongo said that afternoon after we had that horrific accident he spoke to Jackie, Ron, Larry, and County Legislature Gouldman about what steps have been taken to make Tinker Hill safer. He realized that everyone is out there to help us and we have to reach out when we have a problem.

Resident Patty Villanova said there is one section of Albany Post Road heading towards 9D where it is very bad and desperately needs to be paved. It is the best short cut there is and she knows it's really part of Phillipstown. She asked Superintendent Cobb to please see if he can use his connections to get the road cleaned up. Mr. Cobb said he has a meeting tomorrow with the Westchester and Putnam County Highway Superintendents Association and he will mention it. Councilperson Mackay said that is part of the "Old Road Association" and they are not going to budge. Ms. Villanova said the "Old Road Association" is not as powerful as they once were. Mr. Cobb said they did win in court recently though; but will mention it to the Phillipstown Highway Superintendent. Resident Eileen Reilly said until Tinker Hill Road is removed from the Highway GPS people's lives are still in danger. Mr. Cobb said we are working on it but it is falling on deaf ears. Mr. Cummings added that there are many roads which should not be traveled on by trucks, (many of these trucks are coming from out of state and do not know better) which should be removed by GPS. This is a huge problem.

Highway Superintendent Larry Cobb gave his report on what the Highway Department is doing. He said the guys are finishing up the paving; there is still some more to go but it will all be finished up in the next couple of weeks. They are still doing tree work and cleaning up. LEGISLATORS REPORT

County Legislator Gouldman's report is as follows:

School is open. Let's get back to basics and remember road safety. These are our and our neighbor's children – they are also the future of our community so let's keep them safe.

September is "suicide prevention awareness month. This is sometimes a difficult subject to talk about, but if you reach out – there is help out there.

Flu season is here again. The Putnam County Department of Health has scheduled 3 clinics to give out flu shots. Please go to the Putnam County website for times and locations.

The Children's Expo and Public Safety Expo will be occurring on Sunday September 22nd at the Donald B. Smith Campus at 112 Old Route 6 in Carmel.

Please get involved with the 2020 Putnam County Budget process. See how the County gets and spends its revenues. The process starts on October 3rd at 7:00 PM when the Putnam County Executive Mary Ellen O'Dell presents her 2020 budget at the Putnam County Golf Course. I hope you can attend. You do have a voice so please come.

County Legislator Gouldman thanked the residents who have contacted him with their issues and concerns. If there is a problem he can help with he is happy to do so. Please call him as his door is always open at 845-808-1020. He received a few complaints about the road conditions on Columbus Avenue and Oscawana Lake Road. The County Highway Department has cut back the overgrowth in that area which made it a little bit better. Due to complaints from several residents about speeding on County roads throughout the Town, he requested the Sheriff's Department to do speed studies in several different areas including Church Road and Mill Street.

Please slow down it will prevent accidents. Also, a few residents reached out about the traffic light on Peekskill Hollow Road and Oscawana Lake Road. When the power goes out that light used to blink yellow – which was dangerous. Now that light flashes red when the power goes out so please stop when you get there and look carefully.

Resident Patty Villanova asked County Legislator Gouldman about the Sheriff's Department Substation at Oregon Corners. She was interested in the progress of the project and where the grant money is coming from. County Legislator Gouldman said he was talking to the Sheriff about that this morning but does not have any information at this time. He will follow up and get back to her.

Highway Superintendent Cobb and Supervisor Oliverio came up to the podium. Supervisor Oliverio said they were contacted one (1) year ago by a young man named Jake Lomas about putting up a "turtle crossing sign" on Butterfly Lane and Bryant Pond Road - there is a big wetlands in that area and we want to protect the turtles. Supervisor Oliverio invited Jake and his family to be there when Superintendent Cobb and his crew erect the sign. Superintendent Cobb said in springtime there are many turtles around and lots of people try to help them across.

County Legislator Montgomery could not be at the meeting tonight. Her report was read by Michael Bennett.

I am sorry to miss this important Putnam Valley Town Board meeting. I am the Putnam County Laision to the NYS Fish and Wildlife Management Board, a board dedicated to encouraging the preservation and development of fish and wildlife resources on privately-owned lands and waters, and to improve public recreational access to fish and wildlife resources on privately-owned lands and waters. We meet quarterly and, unfortunately, tonight's the night.

There will be two public hearings conducted by the County Executive next week on September 25th, at 4:30pm and then again at 6:30pm. The hearings will take place in Room 300 of the County Office Building – 40 Gleneida Avenue in Carmel.

The first is a Public Hearing to Amend and Revise Chapter 55 of the Putnam County Code Entitled "Ethics, Code of, and Financial Disclosure to Prohibit the Disclosure of Confidential Material" Resolution R#192. The revised law was not yet posted online as of this morning, but information can be obtained by calling the County Executive's office (845) 808-1001.

The second Public Hearing is To Amend Article 5 of the Putnam County Charter Entitled "Executive Department" by adding a new Section 5.04 Entitled "Department of Tourism", which was adopted by the Putnam County Legislature on September 3, 2019 by Resolution R#194.

PUBLIC COMMENT

Presented by Supervisor Oliverio

Resident Patty Villanova explained the 20 year saga that is the Cornu case which she now called "the end of an era". She explained that this is the pink cement house near the Osca Deli which was the artistic dream of Mr. Pierre Cornu. Mr. Cornu got in trouble with the Town who brought him to court for building violations. This ongoing situation cost both the Town and the Cornu family much money and heartache. In 2017 Mr. Cornu's daughter and Ms. Villanova spoke to Supervisor Oliverio who finally was able to get this settled. Ms. Villanova gave Supervisor Oliverio a certificate of appreciation for his part in finally settling the Cornu case. Supervisor Oliverio said the Town Board was also in favor of getting to this outcome.

Councilperson Whetsel said thank you to all who submitted a photo to the Committee for the Conservation of the Environment (the CCE) for their coming exhibition at Town Day called "What's in your backyard". It is a photography display of anything of interest, animals or unusual photography, which you have found on your property. Councilperson Whetsel reminded us to take the time to enjoy the beautiful world we live in. If you submitted a photo that has been chosen - it will be framed and displayed - you can take them home after Town Day. She hopes to see you there.

Resident Ken Kuritzky spoke about Horton Hollow Road. He said last month he was here and Supervisor Oliverio gave him the maps that were done in May. We are now halfway done with September and what is our progression? Supervisor Oliverio said we are waiting for answers from the DEC who claim they will be giving us them very shortly because they also have all the maps which they have been looking at. We did have a phone conference with them but they said there would be a follow up.

We have been waiting for some guidance – we want them to review the maps and review the survey (which they requested) and let us know what we can do. This should be coming shortly. Mr. Kuritzky said usually they want to see the plan first and then they review it. Supervisor Oliverio said they requested to see the topography and the whole layout of that area before anything could move forward. We did that and as you saw the maps are very extensive. All I can do is bother them some more. As soon as there is some contact made we will write up a summary and then go forward. Mr. Kuritzky said you talk about the cost of this project. I think the drainage is being unfairly lumped into that cost – the drainage would have to be done one way or the other whether it gets paved or not because there is no drainage. It hasn't been done for years. Supervisor Oliverio says he agrees - especially the flat area near the Cimarron Ranch. That would be part of the project – if we don't pave it still has to be done – if we do pave and we don't do the drainage the road would fall apart. Mr. Kuritzky added that one of the things they have to do is grade the road. It was done last year but has to be redone before it is paved. Supervisor Oliverio said you have to make sure the road bed is solid but it's all in steps. Mr. Kuritzky said that the DEC said the quality of what they are using now is from the bottom of the barrel. The residents of the road are also worried about all of the silica they are breathing in. Every time a car goes by it goes right into our houses. The road now is not the same road as when I bought my house. Supervisor Oliverio said the County is responsible for repairing the bridge. Councilperson Annabi agreed and said the proof of who is responsible for the repairs has been determined. Mr. Kuritzky said we need a meeting where everybody is there including the Horton Hollow Road residents so we can all be on the same page because the DEC is saying they have not been contacted by the Town. Supervisor Oliverio said that is not true and we can have the meeting you want in November at a public forum like at a Town Board Work Session.

Resident Henry Lopez asked Supervisor Oliverio why if he was so steadfast in moving forward with the Town paying for the Ambulance Corps new boiler, he deleted Resolution #7. Supervisor Oliverio said he did that because it wouldn't pass. He spoke to the Board Members individually where they expressed their concerns. None of them could really recall that this agreement had been made at the budget time, I did, and I claimed that there was a misunderstanding, and I will own that misunderstanding. I am not going to fight my Board over an issue that they feel very strongly about. I knew that it could not carry and I felt bad about it. I checked with Counsel and it was done legally through the budgetary process; unfortunately the Board did not recall approving that money being allocated for them for the furnace. When I see an issue that is insurmountable - the majority wins. Mr. Lopez asked Counsel Florence for his legal opinion on this matter. Counsel Florence said two (2) votes is not a majority. Mr. Lopez said he was asking if in this case the transfer of funds was legal or not. Counsel Florence said as this did not happen it has become hypothetical and he cannot answer something hypothetical. Supervisor Oliverio said Counsel Florence told him that a Resolution was needed to do this with at least three (3) positive votes (which is the majority). I did not have the three (3) votes.

Councilperson Luongo said this Saturday at the Firehouse from 9:30 to 11:30 AM one of the Deputies from the Putnam County Sheriff's Department will be there for "Coffee with a Cop". They will be building relationships" one (1) cup at a time". Also, Saturday October 26th the Fire Department will be hosting a Halloween party. There will be an open bar, dinner and dancing. Dinner starts at 7:00 PM with dancing at 8:00 PM. Costumes are optional, and it is \$35.00 per person. Supervisor Oliverio said it is the best Halloween Party in Putnam Valley – you must attend.

Supervisor Oliverio said just a few days ago a real true Putnam Valley character, John Cohen, passed away. He was a friend of everybody and loved it here. He was at the height of the beatnik and folk era of the 50's and 60's.

He encompassed the vision of artists such as Pete Seeger, Bob Dylan, the New Christie Minstrels and his own band, The New Lost City Ramblers. He was a genius as an artist, political activist, musician, environmentalist, and as a good friend to many of us here in Town. He meant a lot to a lot of people. Councilperson Annabi added that this is a big loss to our Town.

Councilperson Annabi reminded everyone that September 28th is Town Day. Oscawana Lake Road will be closed from the VFW to the Elementary School with shuttle buses at the school. Councilperson Annabi thanked the Fire Police, the Sheriff's Department, Bureau of Emergency Services, Parks and Rec, Highway, Putnam County Golf Course, the bus drivers, and the cadets. The dog park will also be closed for 24 hours. Councilperson Annabi said that there are over 70 vendors such as Shoprite and Mahopac Bank - which is fantastic; there will be a great live band called "House Arrest", and a fantastic DJ and Karaoke. There will be a zip-line and a rock wall, as well as activities for kids of all ages. Town Day starts at 2:00 pm and the fireworks will be 8:30 pm sharp. Entry is free. If you have any questions or want to be a vendor give me or Beverly Kelly a call at 845-526-2121. You can pick up your parking permits and Town Hall from Beverly. Reminder- you will only be able to make a left hand turn coming out of the Town Park for the safety of people walking.
