

ICE RETARDANT DEVICE LAW

Effective December 11, 2019, the use of any ice retardant device or mechanism (deicer, bubbler or aerator) within the entire Lake Oscawana Water Body and/or along the shoreline of the entire Lake Oscawana Water Body, is completely and totally banned from use. Anyone failing to comply with this law will be levied a \$1,000 fine and face confiscation of the offending device. Subsequent offenses by the same individual or property owner will result in a doubling of the preceding fine.
