#### **SUPERVISORS COMMENTS**

Supervisor Oliverio welcomed everyone to the Work Session and reminded the public that the first two (2) meetings of the month take place at 5:00 PM; and the third meeting (which is the Regular Meeting) begins at 6:00 PM.

Supervisor Oliverio said as far as the Covid-19 virus – right now it is business as usual. He added that as of right now there are no known cases in Putnam County and relayed that Putnam County's Commissioner of the Public Health Department, Dr. Nesheiwat, said even though identifying cases here in Putnam is inevitable as testing increases – do not panic. Supervisor Oliverio said, "this too shall pass" and please use common sense and take the recommended precautions such a refraining from large social gatherings, washing your hands frequently, use hand sanitizer and please be safe.

# <u>AUTHORIZE SUPERVISOR TO SIGN AMENDED GRANT CONTRACT</u>

#### **RESOLUTION #R20-118**

**RESOLVED** that the Town Board authorize the Supervisor to sign the amended grant contract with the New York State Dormitory Authority. This grant was originally awarded October 9, 2009 for \$50,000.00. The amended grant is in the amount of \$30,733.00. This reduced amount will be used in conjunction with a grant received from NYSERDA to fund the Towns' Photovoltaic Project. This contract has been reviewed by the Town Attorney.

Town Attorney Lusardi said he wrote a Resolution for this and would like the Town Board to take a roll call vote.

Councilman Luongo said he feels the Town Board is not doing this resolution in the right order. He believes that #6 the discussion on the placing a moratorium on solar farms should be done first. He said how can we tell other people no when we are putting solar panels outside of the Parks and Recreation Building? Supervisor Oliverio said we are not putting in a solar farm just some solar panels – there is a difference. We are most concerned about someone clear cutting acres of land. We need to study this issue before someone wants to deforest a good deal of land and we have nothing on the books. This will not include an individual putting up solar panels on your home. We can base it on wattage or voltage or even acreage. Councilman Luongo said he is not against it – he is only against how they are doing it. Councilwoman Whetsel said this grant is now over ten (10) years old and we don't want to lose the money. Councilwoman Annabi said how can you have a moratorium against solar panels when we are putting them up ourselves? She added that she is also in favor of the grant. Supervisor Oliverio said the moratorium will only pertain to solar farms. Councilwoman Whetsel said moving forward we need to look at our Master Plan to see if we want to protect our forested areas not clear cut to put up a solar farm. We also need to check and make sure there are no endangered species etc. on the land where people may want to put solar farms. Supervisor Oliverio said let's vote on this grant – we are only having a discussion on the moratorium tonight.

#### **DISCUSSION RE: SOLAR FARM MORATORIUM**

Presented by Supervisor Oliverio

Supervisor Oliverio asked Town Attorney Lusardi for some background on this subject. Town Attorney Lusardi said there is a difference between a moratorium and a change in the law. The Zoning Code is silent as to solar farms; so it certainly is worth looking at it, and perhaps making amendments to the zoning code in respect to solar farms. Currently there is nothing in the code that references solar farms. A moratorium would freeze any applications for establishing a solar farm coming into Town pending review, discussion, and an enactment of an amendment to the zoning code. When people become aware you are looking at this they may race to the building department to establish this before a law is enacted to regulate them. At least one (1) party has approached Attorney Lussardi, the Town Planner Board, and the Town Engineer about building a large battery plant to store the energy at night and sell it during the day. There are a number of inquiries about the potential for solar farms in this Town. You must also define what a solar farm is such as size and location. Solar panels do take away from the scenic beauty of an area and can cover acres of land. Someone can take a hillside with solar panels and it would look like there is a billboard there. Supervisor Oliverio said we are only putting up 20 panels - much like you would on a home. Town Attorney Lusardi said you must figure out where you want to draw the line. How big, how many volts, the size etc.

Supervisor Oliverio said we are getting 20 panels – pole mounted with 4 panels per pole. Councilwoman Annabi asked how much room are they going to take up and will people see them as they drive by? Councilwoman Whetsel responded and said we want people to see them so they know we are following the Climate Smart Community directives. Councilwoman Annabi is concerned because she feels it may look unsightly to the neighbors across the street. Councilman Luongo is also concerned that the panels will cause a reflection in the homes of the across the street neighbors. Supervisor Oliverio said we can put them on the side by the dog shelter. Councilwoman Whetsel said the whole Town Board can decide where to put them – we don't want people to go out and touch them either. Councilman Smith said he got a sample Resolution from Yorktown. He liked some of the latitude allowed by the Planning Board and we could make a similar Resolution. Councilwoman also mentioned creating a "Sitting Board". Supervisor Oliverio said we can create a six (6) month moratorium which will give us time to look at this. Councilwoman Annabi said she is opposed to setting a moratorium in place when we are putting up panels. Supervisor Oliverio said people can put panels on their house – we are only looking at people who want to make this a money making business.

Councilman Smith asked if the moratorium, just like a law, be crafted to allow people to still have a certain amount of latitude. Supervisor Oliverio responded in the positive. Councilman Smith then added, then what we are doing can also be done by individual residents as well within the confines of the moratorium. Supervisor Oliverio said the moratorium would just give us time to look at this. "What is not in the code does not exist".

Councilwoman Whetsel noted that if an individual who puts up a solar farm and then abandons it a few years later – leaves behind a huge mess for the Town to clean up. A bond has to be required. Councilman Luongo said when these things outlive themselves – they are considered a hazard. Town Counsel Lussardi said moratoriums can be crafted to satisfy what the Town Board needs. He will include all forms of renewable energy such as wind turbines.

# **DISCUSSION RE: ZONING REVISION WORK BY BRUCE BARBER**

Presented by Supervisor Oliverio

Supervisor Oliverio asked Bruce Barber and Todd Atkinson to take a look at some of the bigger areas of concern in our zoning codes. These are important areas such the Planning Board being able to grant a change order if the vote is a majority plus one (1) (which is a super majority). Supervisor Oliverio would also like to look at making our "corners" which are now residential – commercial/residential. This way we can get some business in this Town. He would also like to make changes in the way we determine an agricultural district. Bruce Barber will explain everything at our next work session. Councilwoman Annabi said she is concerned about the agriculture change. She added that she got all the minutes from when the "RA" was put in place back in 2008. It was done because previously when the County gave an agricultural designation it took away the rights of the Town to stop that homeowner from subdividing. The "RA" allows the Town to control that again. Supervisor Oliverio said he does not want to remove that "RA" he just wants to add that if you lose the County's Designation – you also lose the Town's Designation as well. If you are no longer recognized by the County - then we don't recognize you either. Councilwoman Annabi said we need to keep control of someone who wants to subdivide their property.

Supervisor Oliverio called for an Executive Session at 5:42 PM. Councilwoman Annabi seconded the motion which was unanimously carried.

Supervisor Oliverio reopened the Town Board Meeting at 6:00 PM. Councilwoman Annabi seconded the motion which was unanimously carried. Supervisor Oliverio said no votes were taken in the Executive Session.

Councilwoman Annabi said we will get more information from Bruce Barber about the zoning revisions.

Councilwoman Annabi asked Town Attorney Lusardi about the Planning Board and what the "super majority means". He said in most Towns the Planning Board has the option to waive certain regulations where they do not feel that it is necessary or appropriate. This amendment would give the Planning Board, with this "super majority", (the majority plus one (1)) the ability to waive a submission requirement. This is only for the paperwork you have to give the Board for an application. This does not apply to the review criteria.
