# **SUPERVISOR'S COMMENTS**

Presented by Supervisor Oliverio

Supervisor Oliverio welcomed everyone to the meeting via zoom due to the coronavirus. Supervisor Oliverio thanked the Highway Crew for the great clean-up work they did after the storm we had the other day. NYSE&G got everyone back on line pretty quickly. Also, the Governor passed a new mandate that masks are required whenever you go out in public. You must have a face covering, you can even wear a bandana. Supervisor Oliverio then thanked the Ambulance Corps and all of our essential employees for keeping our country going during this scourge.

#### **DEPARTMENTAL REPORTS**

Presented by Councilwoman Annabi

Councilwoman Annabi read the report from Putnam Valley Volunteer Fire Chief Larry Cobb Jr which is as follows:

- There is a burn ban in effect from March 15<sup>th</sup> to May 15<sup>th</sup>.
- Use caution around downed power lines, always treat them as if they are live.
- When running generators make sure they are far enough away from the house and exhaust is facing away from the house.

Councilwoman Annabi next read the Putnam Valley Ambulance Corp Captain, Sandy Bohl's report which is as follows:

- For the month of March we had 63 calls. 49 of them were medical emergencies, 5 car accidents and 9 other.
- Our members logged in 434 roster hours at the building and another 160 hours from home. I want to thank all the members of the Putnam Valley Ambulance Corps for putting yourselves on the line to help the Putnam Valley Community and risking your own health.
- Our goal is to get our ambulances out to help any of our neighbors in need at this difficult time.
- I also want to thank some of our local residents who have dropped off N95
  masks and other supplies that had at their homes and some that have made
  cloth masks, this includes "The Mask Makers Guild" which gave us around 40
  cloth masks that were given out to our EMT's and paramedics to wear with a filter
  if we ran out of N95's or wear over our N95 masks so they don't get
  contaminated on the outside and last longer.
- Please remember to wear a mask when you are in an area where you can't
  maintain social distancing, even a bandana will work. The cloth masks will
  protect us only if everyone is wearing one; they will stop the water spray that
  comes out while we are talking, coughing etc. and help prevent the spread of the
  virus. Doing this will help keep all of our loved ones safer. Thank you and
  everyone stay safe and healthy.

Highway Superintendent Cobb gave the Highway Report. He said we had a severe storm on Monday into Tuesday and thankfully we made it through. We did get some damage but most of it is cleaned up already. We are working with half crews so I would like to thank my guys for what they did, it's stressful but everyone is working hard. We are not getting everything done with a half crew like cleaning the basins but we are doing what we can. This will be a ripple down effect for everybody. Supervisor Oliverio added that these are difficult times for everybody. Many people are sheltered in place; many people are not working and not getting paid. Hopefully the stimulus checks are on the way. There is a lot of compromise at every turn and let's all have patience. There will eventually be a vaccine and this will end.
