# RESOLVED TO GRANT EXEMPTIONS PURSUANT TO THE REAL PROPERTY TAX LAW SECTIONS 459-C AND 467 STAR PROGRAM

Presented by Supervisor Oliverio

**RESOLVED** that pursuant to Executive Order 202.83, the Assessor is hereby directed to grant exemptions pursuant to Real Property Tax Law Sections 459-c and 467 on the 2021 assessment roll to all property owners who received that exemption on the 2020 assessment roll, thereby dispensing with the need for renewal applications from such persons, and further dispensing with the requirement for assessors to mail renewal applications to such persons.

Provided however, that the Assessor may require a renewal application to be filed when she has reason to believe that an owner who qualified for the exemption on the 2020 assessment roll may have since changed his or her primary residence, added another owner to the deed, transferred the property to a new owner, or died;

Supervisor Oliverio said this Resolution is no longer needed and will be removed as the Governor already granted this. It means anyone with the specialized senior citizen exemption does not have to apply for it this year due to COVID. We don't have to pass this we only have to announce it. The only thing we need to know from our senior citizens is if they have had a significant increase or decrease in their finances.
