#### SUPERVISOR"S COMMENTS

Supervisor Oliverio said we just went through a nor'easter which was tough but kudos to our Highway Department and the County Highway Department. Highway Larry and his Assistant Joe as well as Crew Chief Ray and all the crew did an outstanding job. It's a point of pride, over 40 hours of continuous service clearing our roads.

Attorney Lusardi explained the need for the Town to declare Lead Agency for the new laws being passed. He said the Town Board needs to close the section of the Public Hearing for accepting written comments. He went on and said with that section about to be closed, the Public Hearing is coming to an end, the Town Board needs to do two (2) things before it votes on the law. One (1) is to declare yourself Lead Agency. We sent out Lead Agency notices well over 30 days ago and the Town Clerk has said that there have been no objections. We just need a Resolution for you to act as Lead Agency. The next order of business is for the Town to issue a negative declaration (or a positive declaration if you so deem). The Town Planner has prepared a draft negative declaration which he recommends to the Board. Attorney Lusardi recommends it as well because neither of them sees any negative environmental impacts with the laws you are looking at passing. After doing those two (2) things you can vote on the laws. The Comcast Contract does not need to be part of the negative declaration because it is only a contract.

Supervisor Oliverio said we will vote on the Noise Ordinance tonight but we are going to change it from its present version. It will most likely get a no vote tonight. We are preparing a shorter more comprehensive noise ordinance. We will have to have another Public Hearing on it. We really needed to do some major changes, we would like it done before the spring.

#### ISSUANCE OF NEGATIVE DECLARATION

Presented by Supervisor Oliverio

Supervisor Oliverio said our Planner did not see any negative environmental impacts for any of the proposed laws. Town Attorney Lusardi agreed with Supervisor Oliverio and said now would be the time that the Town Board would do an environmental review of the proposed actions. The Town Planner and Attorney Lusardi agree that there are no significant environmental impacts that arise from the proposed statutes. The Sign Law just limits the size of the signs and the time frame you can have them up. The CCA law just authorizes the Town to participate in the program, it is not mandatory.

Town Attorney read the Negative Declaration as follows:

#### Description of Action:

STODA Statem

Generally, the proposed revisions are intended to provide the following:

- Standards for the installation and removal of temporary political signs.
- Adoption of the Community Choice Aggregation (Energy) program in order promote energy conservation in a cost-effective manner to the residents of Putnam Valley and in part meet the requirements to be designated as a Clean Energy Community by NYSERDA.

Specifically, the proposed revisions involve:

- Revision of Chapter 165-53 of the Town Code (Zoning) entitled; "Temporary Signs".
- Creation of a new Chapter 166 of the Town Code entitled; Community Choice Aggregation Program.

The overall effect of the proposed code revisions will be:

 To provide greater clarity regarding the use, installation, and removal of temporary political signs throughout the town.

 Implement a solar energy program in which the town will be included as part of an aggregate of communities obtaining solar power at a reduced rate to town residents. Adoption fulfils one of the requirements to be designated as a Clean Energy Community by NYSERDA and makes available certain grant opportunities for energy improvements and policies.

Location: Town of Putnam Valley, Putnam County, New York.

Reasons Supporting This Determination: The Town Board has compared the proposed action with the Criteria for Determining Significance in 6 NYCRR 617.7 (c), specifically:

The proposed action will not result in a substantial adverse change in the
existing air quality, ground or surface water quality or quantity, traffic or
noise levels, or a substantial increase in solid waste production.

There are no proposed changes to any of the existing environmental regulations or thresholds in which proposed actions require applicable permits and therefore existing air quality, ground and surface water quality or quantity, noise levels, or solid waste production is not negatively impacted.

2. The proposed action will not result in the removal or destruction of large quantities of natural vegetation or fauna; substantial interference with the movement of any resident or migratory fish or wildlife species; impact a significant habitat area; result in substantial adverse impacts on a threatened or endangered species of animal or plant, or the habitat of such species; and will not result in other significant adverse impacts to natural resources.

There is no proposed land disturbance associated with the proposed action. All existing town environmental ordinance permitting thresholds shall remain the same.

 The proposed action will not result in the impairment of the environmental characteristics of a Critical Environmental Area as designated pursuant to 6 NYCRR Part 617.14(g).

There are no designated Critical Environmental Areas within or directly adjoining the Town of Putnam Valley.

The proposed action will not result in a material conflict with the Town's
officially approved or adopted plans or goals.

The proposed changes continue to the Town Code continue to support the applicable goals of the comprehensive plan found on page 7 of the Section 3' "Vision and Goals" of the current comprehensive plan with respect to the promotion of energy efficiency and conservation, and the use of renewable energy in the town. Additionally, Section 3, "Vison and Goals" articulates the following: "Retain the scenic, meandering, rural character of roadways that traverse Putnam Valley'.

Pages 56-57 Section 4 ("Plan Recommendations") of the Town Comprehensive Plan contain specific tasks to be considered in promoting the use of alternate energy sources and energy efficiency within the Town. Additionally, Page 60 of Section 4 contains specific recommendations regarding transportation, visual quality, and the preservation of scenic resources.

- The proposed action will not result in the impairment of the character or quality of important historical, archaeological, architectural, aesthetic resources, or the existing character of the community or neighborhood.
- The proposed action will not create a hazard to human health and safety as all applicable health and safety regulations will be followed.
- 7. The proposed action will not create a substantial change in the use, or intensity of use, of land including agricultural, open space or recreational resources, or in its capacity to support existing uses.
- 8. The proposed action will not encourage or attract a large number of people to a place or place for more than a few days, compared to the number of people who would come to such place absent the action.
- The proposed action will not create a material demand for other actions that would result in one of the above consequences.
- 10. The proposed action will not result in changes in two or more elements of the environment, no one of which has a significant impact on the environment, but when considered together result in a substantial adverse impact on the environment.
- 11. When analyzed with two or more related actions, the proposed action will not have a significant impact on the environment and when considered cumulatively, will not meet one or more of the criteria under 6 NYCRR 617.7(c).

12. The Town Board has considered reasonably related long-term, short-term, direct, indirect, and cumulative impacts, including other simultaneous or subsequent actions.

WHEREAS, a negative declaration was issued by the Town Board as annexed hereto;

I am writing to express my support for Putnam Valley to proceed with further study, education, and community outreach for the Community Choice Aggregation (CCA) program. The CCA is likely to provide savings for the homeowners of Putnam Valley and also help to combat climate change.

By joining together as a town, we can negotiate better electric power prices, and better consumer protections, than each of us would be able to negotiate on our own. For those individuals who prefer not to join, opting out is not hard, and it can be done at any time, without any penalty.

Towns that have chosen CCA membership have found that it resulted in lower energy bills and savings for their citizens. For example, in Westchester, 110,000+ homes and small businesses saved more than \$17 million in the first two years of the program.

In addition, towns that choose to participate in CCA programs may also become eligible to apply for NY State grants for local Climate Smart infrastructure (for example: solar panels for municipal buildings, electric cars for town fleets, and electric car chargers for public spaces). Of course, there is no guarantee for lower homeowner electric bills, for state grants for the Town, or even that we will be able to combat climate change quickly enough to make a difference. - A (3) Signs shall not exceed 16 Square Feet in area"

A new section A (5) is hereby added stating as follows:

"A violation of Town Zoning Code Section 165-53 A shall be punishable by a fine of \$100.00 per day for each day that a sign remains in place in violation of the Section. Such violation and fine shall be imposed and levied upon the committee to elect the candidate whose name is placed upon the sign and the person who installed the sign

Members of the Putnam Valley Town Board.

Thank you for taking the time to read my comments.

It is my understanding we are discussing an **addition** to the noise ordinance already on the books - to add a dB cap (similar to neighboring districts) to the existing town code in order to enforce excessive, unreasonable, unreasonably loud, disturbing, unnecessary, annoying and offensive noises during the day which are a detriment to the enjoyment of property, keeping in mind the current wording "Not intended to discourage enjoyment of reasonable activities".

The moments of quiet bliss in my home have been fleeting since my husband and I moved up here in '99. We could not predict that the 3 apartment house next-door would turnover from 4 respectful quiet adults (all of whom knew my now deceased husband) to a total of 11 occupants now (an increase of 2 just yesterday) of 5 adults and 6 young adults/kids...

Times change....

I am extremely sensitive to external noise and will be the first to admit it. I can be distracted very easily. To combat the disruptive increase around me, I have purchased noise canceling headphones, I play a soft babbling brook of white noise to drowned it out, I shift and do something else knowing the noise will end, eventually. I'm not happy I have to do these things but I need to stay sane.

But there are some sounds that I and others can't get away from.

Sound waves so powerful they rattle the windows and the vibration can be felt in every room in the house. It comes across the lake from an entitled neighbor blaring his music with the bass cranked to full for all to hear. It comes from the disrespectful kid who parks in front of your house and blares his car stereo 'because he can'. And, because I no longer have encounters with the new renters next-door because of the pushback, vindictiveness, and ugly encounters I've had with them (before calling the sheriff), it comes from illegal fireworks and gunfire.

I therefore am in favor of adding anything that will help with enforcement...

There was a time of common courtesy, when neighbors would immediately remedy a situation if informed it was disruptive or disturbing.

Times change...

To the Town Board,

Respectfully, I am writing to encourage the Town Board to defer passing a new noise ordinance until further study can be carried out. The proposed decibel levels for daytime (8am - 6 pm) of 70 dB(A)'s and nighttime (6pm - 8am) for 55 dB(A)'s are reasonable and in keeping with community norms.

However, a limit of 110 dB at the property line for property maintenance equipment (leaf blowers, chain saws, etc) is very high, is not adequate protection for hearing loss, especially (though not only) in the lake communities, and poses a health risk to the residents of Putnam Valley. In my opinion, the proposed law should not be passed as it stands now. Further study is needed.

- Hearing loss is related to both the loudness (decibels) and the duration of the sound. According to the NIH (National Institute of Health) "Scientists recommend no more than 15 minutes of unprotected exposure to sounds that are 100 decibels. In addition, regular exposure to sounds at 110 decibels for more than one minute risks permanent hearing loss." (see attached FAQ sheet from the NIH)
- 2. Homes in lake communities have an additional issue with the transmission of noise. Across water, noise does not diminish with distance in normal predictable ways, as it does over land. In fact, because of a "megaphone effect," noise from a chain saw or leaf blower may be louder when perceived from across the lake, than it is at the owner's property line. Thus, high statutory limits for noise "at the property line," and without a limit of duration will not provide hearing loss protection, especially (though not only) in the lake communities.

Attached are also noise guidelines from the state of Minnesota ("Land of Lakes"). The Minnisota guidelines are notable in that they do take into account duration as well as loudness of noise. Minnesota accepts noise levels for residential areas at 65/55 dBA and, interestingly, for industrial areas (commercial, agricultural, forestry, amusement parks) at 75/80 dBA)\* This should give some indication of how loud 110 decibels is. The decibel scale is logarithmic, not linear. Thus 110 decibels is not twice as loud as 55 decibels--110 decibels is more than 100,000 times as loud as 55 decibels. (Compared to 55 decibels, 65 is 10 times louder, 75 is 100 times louder, 85 is 1,000 times louder, 95 is 10,000 times louder, and 105 decibels is 100,000 times louder than 55 decibels)

Thank you for your time and attention. I am not opposed to amending the noise ordinances. Noise is increasingly identified as a pollutant and a health hazard. However, I believe the proposed law needs further study.

\*The Minnisota limits for a residential location are L10 = 65 dBA and L50 = 60 dBA during the daytime and L10 = 55 dBA and L50 = 50 dBA during the nighttime (Minn. R. 7030.0040). This means that during the one-hour period of monitoring, daytime noise levels cannot exceed 65 dBA for more than 10 percent of the time or 60 dBA more than 50 percent of the time.
