SUPERVISOR'S COMMENTS

Supervisor Oliverio said please whenever there is an alert for weather keep your cars as far removed from the side of the road as possible. Use your parking space if you have one (1). It is very difficult for our trucks to get around when cars are in the middle of the street or right on the side of the street. Go as close to the curb as possible. Our crews have been working non-stop with the amount of snow we have been getting. We also know you don't like your driveways blocked, but when there is a foot and a half of snow, some of it will wind up at the end of your driveway. No one means to do it but there will be some residual snow in your driveway. Councilman Luongo said the more snow you can put to the right side of your driveway the less snow you will get in. Do not throw snow in the road, it creates another hazard. Please ask anyone who plows your driveway to clean up after themselves. Supervisor Oliverio said there are fines attached to throwing snow onto the roadway. There is also much more snow on the way.
