DISCUSSION - CCA TIME TABLE

Presented by Councilman Smith

Councilman Smith said we have moved into the education and outreach part of the plan. The CCA is now explaining this clean energy low cost electricity program to the local households. That is of course at no cost to us. Councilman Smith thought it would be a good idea to get the three (3) zooms that have already taken place on the schedule so people can see them. If anyone has a group that would like the CCA to come speak to them by zoom please let the Supervisor know.

DISCUSSION ABOUT AMENDMENT TO THE NOISE ORDINANCE

Presented by Supervisor Oliverio

Supervisor Oliverio said they have done a lot of work on the Noise Ordinance and have been able to condense it and update it. You do want to satisfy the people who have been harassed; but you don't want to impact the general public. If you want to have a law - make it specific and targeted. If you are moving in a boat you are fine.

Councilwoman Annabi read the intended new law which reads as follows:

Amendment to Chapter 82 "Noise Ordinance"

§82-1 Title (this remains the same)

§82-2 Intent (this remains the same)

§82-3 Definitions (this remains the same)

§82-4 Prohibition (this remains the same)

§82-5 NOISE RESTRICTIONS:

- A. During the daytime hours of 7AM to 8PM prolonged noise levels of 70 decibels or more lasting more than or continuing for a total period of time exceeding 15 minutes during the daytime hours between 7AM to 8PM of any given day shall be prohibited. The noise level shall be measured using a calibrated decibel meter from the property line of the complainant. The above ordinance restriction shall apply only to the revving of cars, loud music, artificially amplified voices and/or artificially amplified sound producing devices.
- B. During the hours of 8PM to 7AM prolonged noise levels of 60 decibels or more continuing for a total period of time exceeding 15 minutes during the hours between 8PM and 7AM of any given day shall be prohibited. The noise level shall be measured using a calibrated decibel meter from the property line of the complainant.

§82-6 Persons liable for violations (remains the same)

§82-7 EXCEPTIONS

- A. Exceptions to the daytime restrictions set forth in §82-5A above shall expressly not apply to the following: Ongoing construction, yard maintenance, yard and construction mechanisms and tools, air conditioners, generators, snow-blowers, hand tools, chain saws, land or water craft that are not stationary and one (1) day events i.e. birthday parties and/or recognized Federal Holiday Parties
- B. The restrictions set forth in §82-5B shall expressly not apply to "Exceptions" to the evening restriction are the following: Air conditioners, generators, all moving land vehicles, tools needed during a weather or national emergency and one (1) day celebratory events, (birthday parties and/or recognized Federal Holiday Parties) which must end by midnight wherein the noise restrictions will be imposed at midnight
- C. The Municipality and all utilities shall be exempt from any and all restrictions as regards to necessary maintenance repairs and all emergency response during a weather event or national emergency.
