**PRESENTATION “OPT” – SOLAR ENERGY SUPPLIER**

Presented by Supervisor Oliverio

Joe Montuori from Sustainable Putnam and Corinna Ricard from Ampion Renewable Energy gave a presentation for a NYSERDA opt –in community solar program. The information is as follows:

## **NYSERDA Community Campaign: Opt-in Community Solar**

Mr. Montuori said this form of solar energy does not require people to put solar panels on their homes. Every resident who signs up voluntarily gets a \$100.00 signing bonus. Your community would be a Clean Energy Community and a Climate Smart Community. This form of energy also helps to eliminate greenhouse gases, it doesn't require a lot of effort and your Town can also make some money.

Ms. Ricard said New York State has large renewable energy goals that they are trying to meet and not everyone can afford to have solar panels put on their home. Community Solar is the answer, it takes ten (10) minutes to fill out the form, there is no shopping around, no installation, and you get an up to a 10% savings on your electric bill. We partner with local communities so residents know this is legitimate company and they don't have to worry. When you fill out the form you get matched with a solar farm and you start to receive a credit within 90 days, which you will see on your bill.

Mr. Montuori said everything will be on one (1) bill from NYSE&G. The solar credits are shown on this bill. Every month there will be a different amount of solar energy produced because of the weather. That means you will not get a 10% discount every month but overall you will see a 10% savings on your bill over the course of a year.

The Town also will get a \$5,000.00 contribution when they get 10 people to sign up for this service. Ms. Ricard said Putnam Valley would need to choose a fund to place the contributions in which need to be community based. These funds can be used for such projects as building sidewalks, a park project, or anything that benefits the residents etc. which has to be chosen ahead of time. In addition, each resident that signs up gets a \$100.00 Visa gift card.

Mr. Montuori said the reason Sustainable Putnam chose Ampion to work with is because they are a Public Benefit Corporation, which means they have to give back to the community. They also have an excellent reputation and track record. They have experience doing this with other Towns upstate so they know how to help a Municipality get this on track. He added that NYSERDA is realizing that a lot of people were not signing up. They came to the conclusion that when you have Municipalities signing up it makes people feel more confident. Once your Town decides to participate in this program, you need to start a promotion so your residents are aware of this opportunity. You need at least ten (10) subscribers to begin. You should put a link to the sign-up page on your website. We are the administrators of this program and will do the leg work. There are no penalties if you decide to opt-out if you are not happy with the program, it does take 60 – 90 days for this to happen. The Town itself and local commercial entities can also enroll and get the discounts as long as there is room on the solar farms. This is a finite resource, right now we have plenty of room. This will not affect the power supply and your appliances will run the same. A Resolution is not required; but a press release would probably serve you better. There is a time limit involved with signing up because of the amount of room there is on solar farms, the time limit can be extended if necessary. Remember this is an opt-in program not an opt-out. Our solar farms are all located on fallow farm land, no trees have been taken down.

### **SUPERVISOR'S COMMENTS**

Supervisor Oliverio said to the people of the Lake Districts, he knows there have been a lot of beach closings but with this amount of humidity, heat, and torrential rain it brings the nutrients running rampant into the lake areas, and then the next day it's in the 90's and humid, that is the perfect boiler plate to prepare a harmful algae bloom soup. It is toxic and can kill you or your pets, that's why you don't want to go near it. It does get dispersed when the wind blows or when the weather gets cooler. We are not trying to deny you your swimming rights, we are trying to protect your health. The Department of Health checks our lakes and they are the ones closing them down for your health and safety.

Legislator Gouldman is sorry he could not be here tonight, He has two legislative committee meetings and has asked me to give his report.

\*\* As of today, he has no additional information on the Peekskill Hollow Road improvements. As soon as he knows he will let us know.

\*\* At the most recent Putnam County Legislative Audit Committee meeting on June 28th, the PFK O'Connor Davis firm presented a "Glowing" audit of Putnam County's fiscal standing. They said that the financial health of the county is strong and is one of the best in the lower Hudson Valley. The legislature has done a good job holding down spending and maintaining vital programs for the residents of Putnam County.

\*\* Bill has requested to have the traffic light at Putnam Valley High School be changed to a flashing yellow light during the summer. It has worked very well in the past. The light will be turned back to a regular traffic light when school begins.

\*\* Putnam Valley has an abundance of natural bodies of water for all to take advantage of. Legislator Gouldman would like to urge everyone to take all necessary precautions while using the water to ensure this is a safe summer in the county.

**SCHOOL REPORT**

Presented by Supervisor Oliverio

Supervisor Oliverio said the School District is waiting on instructions from the State on mask wearing. Right now the Governor wants to bring the children back full time but will they wear masks or not? Putnam Valley has a very high vaccination rate mainly because of our seniors. This in turn filters down to the rest of us, but there is no vaccine for our children yet. SUNY's Schools will not require masks for vaccinated people.

Councilwoman Annabi said no masks are needed in school for the summer - this is for September when the kids return in the fall. She welcomed David Kantrowitz the School District's new Athletic Director. Councilwoman Annabi noted that if you know of a family or a family who needs food you can call 211 and they will help you find the nearest food center.

**DISCUSSION ON POSSIBLE LOOKOUT MANOR RESTRICTION ON MOORING BOATS BY THEIR DOCK**

Presented by Supervisor Oliverio

Supervisor Oliverio said we had a few residents from Lookout Manor very concerned about boats and other aquatic crafts crowding out their swim area and beach. Supervisor Oliverio added that the rules on Lake Oscawana are very clear, all aquatic crafts must be 500 feet from any swim area or dock when you moor your boat. When you launch you don't want to run into anybody. We would just be putting together a reinforcement of the current law that is more strongly worded, which would just be applicable to Lookout Manor. It would read that any aquatic craft must be 500 feet away from the shore and swimming areas. This would need a Public Hearing.

**DISCUSSION ON GOOSE REPELLENT SPRAY**

Presented by Supervisor Oliverio

Supervisor Oliverio said in Lake Peekskill particularly North Beach there is a terrible goose waste problem, which we have discussed before. We have looked at using dogs, but the residents did not like that. Now we are looking at using a goose repellent spray. It is a cinnamon and a grape seed spray because geese hate both of those smells. This will keep the geese from landing in the grassy areas and hopefully keep them away. For the cost of about \$3,000.00 over the course of the rest of the summer, we can hopefully keep them away humanely.

Councilwoman Annabi said the only problem she has with it is when it rains it has to be redone and the geese will be leaving in the next two (2) weeks anyway because right now they are molting. They should start this next year not this year. Supervisor Oliverio said it works its way into the ground and the smell would still be there. It would have to be a torrential rain for it to wash away. Councilwoman Annabi said the District Budget Meetings are in August and we should wait until then to decide what they want to do. She does not want to take any action now because she thinks the District should make that decision. Supervisor Oliverio thinks the District wants them to pass it and do this now. We could call them, or email them tomorrow and make sure they want to spend the money. Supervisor Oliverio said sometimes some people are loud but the majority does not want it. We need to find out what the majority of the residents want; so we will hold this for now.


