Hi Everyone,

As agreed to, I purchased 5 Montgomery Spruces on 9/30/21 from Hardscrabble Farms and planned to plant them tomorrow. This evening I met with Al & Tom to go over the placement of the new trees. During our discussions on site and to their surprise, the trees are a lot smaller than they thought and won't serve the purpose of screening as they remain relatively small evergreens.

I will be returning the 5 Montgomery Spruces back to my vendor tomorrow morning.

As an alternative this is what I recommend:

Near the fence line adjacent to the water: white spruces do well in wet soils: 2- White Spruce 6'-7'

Near the swing set, where it is a bit drier: blue spruces will do well 3- Blue Spruces 5'-6'

Build this area up with a topsoil berm

The total cost for the 5 trees, delivery, topsoil and labor is \$3,400.00

These are much different trees (including the size of the rootballs) in comparison to the requested Montgomery Spruces.

Please let me know how you would like to proceed.
