# PRESENTATION BY SYNDER & SNYDER FOR CONCEPT APPROVAL REGARDING PORTERS ROAD WIRELESS FACILITY

Presented by Councilman Luongo

Mr. Robert Gaudioso, a Partner with the Law Firm of Snyder & Snyder got up to speak. Attorney Gaudioso said he is here with the President of Homeland Towers, Mr. Manuel Vicente, and Regional Manager, Mr. Klaus Wimmer. Mr. Gaudioso said this presentation tonight is a Concept Approval for a wireless facility. Homeland Towers has worked with the Town before. This facility will be located at 30 Porters Road which is adjacent to the Con Edison power lines, the closest resident is 667 feet away from this area. The property is unique and comes with a dilapidated house on it. The idea is for Homeland Towers to purchase the property rather than lease it, which is what they usually do. Once that happens we will remove the abandoned house. Procedurally this is a long process in the Town of Putnam Valley because there is a lot of back and forth between Boards. We are here tonight with just the initial presentation to show the Town Board that this part of Town has a persistent coverage problem. We have been looking for a site in this area for a long time. There are challenges to the property on Porters Road because it is an old odd lot with the dilapidated house. We had submitted a ton of information in December which is being reviewed by your Boards. The coverage information we submitted shows T-Mobile has a gap, as do other carriers in this area. We think this facility will remedy this gap.

Councilman Luongo asked if there will be a place on the tower for Emergency Services. Mr. Vicente responded by saying sometimes people forget why we are here in the first place, your Town does have a coverage problem. Peekskill Hollow Road being it is a Hollow has a huge coverage problem, so we were happy to find this site.

It is an odd property but it really is a good location which solves this problem. We will make this available for public safety, which is a policy of Homeland Towers. It is important that we do that because we don't need more towers than are needed, and the infrastructure needs to grow to provide better coverage; so it's important to co-locate everyone that has a need on it. It is designed structurally to handle public safety. In addition, we have been working with Putnam County and the Office of Emergency Management with their project to improve communication throughout the County. We have developed a few sites with them – they are almost done with their core network for that new communication system. This will be a digital system with redundancy, so it's really important. We anticipate that they will be coming on this site as well, and we are preparing for it. When our First Responders go out if they don't have the ability to call it puts them in danger. Mr. Vincente believes every tower that they build; he knows they are saving lives. In addition, we do not charge local Public Safety for using our towers.

Councilwoman Tompkins asked what the coverage distance-wise of the Tower is. Attorney Gaudioso said we submitted some maps and in this case it is pretty extensive, because we are in a good location. When it does hit a mountain it is blocked; and when it hits trees it's attenuated; so we cannot give you an exact distance. The maps do show what area it will cover.

Highway Superintendent Shawn Keeler asked if they will have trouble getting all of their equipment into this area using the road that is there. Attorney Gaudioso said the hardest part is building the tower because we have got to get cement trucks up there. Porters Road is good for most of the way, the top half gets a little steep and we may have to do some smoothing out there. The hard sites are the good sites because they are out of the way. People ask why we are not on the Con Ed towers. The answer is because you can't get to them.

Councilman Luongo posed a query, "why do you need so many towers?" He continued and said if you have XM radio and you travel across Church Road all winter long you have no problems. As soon as the trees bloom with their leaves you now have spotty service. This is why we need multiple towers, the trees have grown over the years. Attorney Gaudioso said the increased use of wireless service, especially during Covid, has grown tremendously, it has become a necessity now more than ever.

Supervisor Annabi thanked everyone for coming and said at the meeting on May 18<sup>th</sup> they will vote on whether to approve or not the Concept.

# APPROVE HOURLY RATE INCREASE FOR SEASONAL LABORERS

Highway Superintendent Keeler said they will start on June 6<sup>th</sup> and work 40 hours per week. The end date will be September 2<sup>nd</sup> and the job itself entails flagging and some light manual labor. You must be at least 18 years old to apply and can be either a man or woman.
