Supervisor Annabi expressed her thanks and appreciation for all he has done for our community and our roads.

DEPARTMENTAL REPORTS

Highway Superintendent Shawn Keeler gave the following report:

Superintendent Keeler also thanked Mr. Kuchera for all of his service and hard work.

I'd like to take a moment to thank the men and women of the Highway dept. for their hard work and dedication over the past 6 months

Our vacuum truck has been out cleaning catch basins around Town. We have cleaned out roughly 312 basins since last month's report, and 568 year to date. We will be continuing this until the fall with the hope of getting all basins in town cleaned by then.

We have been out repairing MANY of the basins that were in need of repair and will be sending out a 2nd crew to assist with getting them all repaired.

Our mower has been out almost every day cutting back along the sides of the roads. As well you may have seen a crew out weed whacking around guard rails and other obstructions the mower can't mow around.

We have been working on replacing and updating the drainage On Sprout brook Road and hope to have it completed by the end of next week, when we will then start cutting the shoulders in preparation for reclaiming of the road scheduled to begin August 25th.

I met with our black top company and I'm awaiting price breakdown for each road on our wish list and will decide shortly which roads will be blacktopped in 2022.

Lastly our Tree crew will be getting back in full swing tomorrow cutting dead trees and limbs over the roads.

Just a quick reminder that if you have trees, bushes or hedges that grow into any road way, it's your responsibility to maintain them. If our guys come through they may cut them back but maybe not to your satisfaction

Supervisor Annabi thanked some of the sponsors of Town Day i.e. The Ana Anastasia Foundation who donated \$5,000.00, PCSB who donated \$2,000.00, and Hudson Valley Gateway Chamber who donated \$250.00. The fireworks will begin at 8:15 PM.

Supervisor Annabi said on October 16th we will be having our next shred event. Start boxing up your documents and get here between 10 AM and 2 PM on that day. It was very successful last time when we did it in March. We are going to continue doing this twice a year.

LEGISLATIVE REPORTS

Presented by Supervisor Annabi

Legislator Nancy Montgomery said she and Supervisor Annabi were at the Rules Committee meeting of the Putnam County Legislature last night where the Legislature voted to go ahead with the Town's ARPA Funding request and share the sales tax gross. You can read about this in the minutes of their meeting. This funding is essential for your infrastructure projects which are very expensive.

Legislator Montgomery was surprised by the third Resolution the County Executive presented last night, (which was the 14 million dollars left over after all of the Towns received their ARPA money), because she never received any proposals or suggestions with what to do with this leftover money. The three people on the Rules Committee moved it forward and what it is earmarked for sounds great on paper. It will be spent on projects such as radios, school safety, infrastructure upgrades, stabilization center, and Highways all lumped into one (1) Resolution. County Legislator Montgomery will be keeping a close eye on this because even though these are worthy projects, she will have a hard time voting for it because they are lumped into one (1) Resolution. Additionally, the Public had no input on this, and this was just presented to us yesterday.

Supervisor Annabi said the money we received from the County was \$602,000.00 in ARPA Funds and \$602,000.00 in sales tax. This money will be used for potable water, sewer treatments and lakes. We were also talking about doing the drainage from Wenonah to clean up Lake Oscawana. Another project we were also talking about is using some of this money for engineering costs in regards to bringing sewers from Oregon Corners up to Lake Peekskill. This sounds like a lot of money, but it's a drop in the bucket when it comes to big projects like these. It is a start though to get our lakes in healthy order. Any step we take using this money has to be approved by the County first. Legislator Montgomery said that is correct, but there is an allowance built in if you want to change course and pick another project than what was originally stated. The guidelines from the Federal Government are fairly flexible as far as changing projects is concerned.

VOTE ON ABACA CODE CHANGES - LOCAL LAW #1 OF 2022

RESOLUTION #R22-233

BE IT ENACTED, that the Town Board of the Town of Putnam Valley does hereby adopt by Local Law Town Code Article VI entitled "Advisory Board on Architecture and Community Appearance" (ABACA), attached hereto as Exhibit A, which will replace the Town's existing "ABACA" policy; and

BE IT FURTHER ENACTED, that the Town Board does hereby waive a verbatim reading of Exhibit A and does direct that said Local Law shall be spread across the record as if it, in fact, had been read verbatim; and

BE IT FURTHER ENACTED, that a Public Hearing in relation to said Local Law was held on April 20, 2022 at 6:00 PM at the Town Hall, 265 Oscawana Lake Road, Putnam Valley, New York; and

BE IT FURTHER ENACTED, that notice of said Public Hearing was given pursuant to the terms and provisions of the Municipal Home Rule Law of the State of New York; and

BE IT FURTHER ENACTED, that this action to amend the Town Code is a Type II Action under the New York State Environmental Quality Review Act (SEQRA), and, as such, no further environmental review is required: and

BE IT FURTHER ENACTED, that the proposed Local Law was duly referred to the Putnam County Department of Planning, Development, and Public Transportation, and no response was received; and

BE IT FURTHER ENACTED, that the said Local Law has been on the desks of the members of the Town Board of the Town of Putnam Valley for at least seven (7) days, exclusive of Sunday;

BE IT FURTHER ENACTED, that said Local Law, if adopted, shall take immediate effect upon filing with the Secretary of State.
