#### **BUDGET DISCUSSION**

Presented by Supervisor Annabi

Supervisor Annabi said the budget has been out for about two (2) weeks now. It has been posted on the website as well. You can also pick up a copy in the Town Clerk's Office. The increase we are looking at is 1.84%, with the only increases being our State Mandates and our Union Contracts. The only question Councilman Luongo had was about the changes regarding the Director of Finance contractual line. Supervisor Annabi told him that line not only includes the Director of Finance, but also the part-time employee. Supervisor Annabi said the other discussion was about the line regarding the Facilities Manager. This is the salary of the new Facilities Manager, (which is \$50,000.00 per year), and the position of the IT person. Supervisor Annabi also mentioned that the cost of LOSAP went down. Also included in this budget is the increase in Retirement, Workman's Comp., and Insurance etc. The Public Hearing for the budget will be held on October 19<sup>th</sup> at 6:00 PM. She added you can call, e-mail, or come in person to discuss this, my door is always open.

Supervisor Annabi said that there is another Public Hearing on the night of October 19<sup>th</sup> at 6:00 PM, which is the cell tower slated for 30 Porters Road. Counsel Ryan said it is for a Special Use Permit to erect a new cell tower.

## APPROVE THE 2023-2025 CONTRACT FOR THE DISTRICTS SOLID WASTE AND RECYCLING COLLECTION

Presented by Supervisor Annabi

Supervisor Annabi said the garbage contract came in a lot lower than the surrounding towns. She believes it is because we have a three (3) year contract and they may not.

#### **RESOLUTION #R22-316**

**RESOLVED** that the Town Board authorize the Supervisor to accept the lowest bid; and sign the contract from AAA Carting, 480 Furnace Dock Road, Cortlandt Manor, NY 10567 for the Special Districts Solid Waste and Recycling Collection Services. The term is for three (3) years beginning January 1, 2023 and ending December 31, 2025. This was the only bid received.

The lump sum bid is a follows:

2023 - \$288,543.84 2024 - \$305,903.52 2025 - \$324,317.75

The Special Districts include: Abele Park, Hilltop Estates, Lookout Manor, Wildwood Knolls, Roaring Brook Lake, Glenmar Gardens, and Brookdale Gardens

#### APPROVE LAKE PEEKSKILL COMMUNITY CENTER FURNACE PUMP UPGRADE

#### **RESOLUTION #R22-317**

**RESOLVED**, that the Town Board authorize KARACO to upgrade the furnace pump at the Lake Peekskill Community Center to a condensate pump with neutralizer for acidic water. The acidic water is a byproduct of the furnace. This upgrade will bring the unit up to NYS code. The funds will come from the District. The total cost is \$655.00.

Councilman Luongo asked didn't we do a lot of work recently on the heating system? Supervisor Annabi thinks the work was done on the AC, but she will check. Supervisor Annabi said this is to upgrade the entire unit because it is not even up to code. Councilman Luongo said as long as that is what everyone remembers he is fine with going ahead.

#### APPROVE LAKE PEEKSKILL LOWERING 2022

#### **RESOLUTION #R22-318**

**RESOLVED,** that the Town Board authorize the Lake Peekskill District Employees to begin lowering Lake Peekskill by five (5) feet from its normal level.

Supervisor Annabi seconded for discussion,

Supervisor Annabi said this process began on September 30<sup>th</sup>. Due to the drought the lowering will be five (5) feet total – not five (5) feet from where it is now.

#### APPROVE ROARING BROOK LAKE DRAWDOWN 2022

#### **RESOLUTION #R22-319**

RESOLVED, that the Town Board authorize the Roaring Brook Lake Dam Custodian, Sam Lee, to begin lowering the Lake no earlier than October 15<sup>th</sup> and no later than November 5<sup>th</sup> based on Sam's discretion. Sam will take into consideration the existing Lake level and weather patterns to determine when to open the valve. The Lake will be drawn down to the default level of between 3 ½ and 4 feet. It will be maintained at that level for the rest of the winter.

#### AUTHORIZE SUPERVISOR TO SIGN NYSE&G AGREEMENT

#### **RESOLUTION #R22-320**

**RESOLVED**, that the Town Board authorize the Supervisor to sign the NYSE&G Agreement. The Agreement is to convert 1 floodlight on Lake Drive in Lake Peekskill to LED. The conversion will have a one-time cost of \$60.66. Converting this light will save the Town approximately \$190.00 per year. The Lake Peekskill Improvement District will cover the cost.

### APPROVE ASBESTOS & XRF LEAD-BASED PAINT SAMPLING FOR WILDWOOD KNOLLS WATER TANK AND WATER HOUSE

#### **RESOLUTION #R22-322**

**RESOLVED**, that the Town Board authorize the Supervisor to enter into a contract with Quality Environmental Solutions & Technologies, Inc., 1376 Route 9, Wappinger's Falls, NY 12590; regarding a proposal for asbestos and XRF lead-based paint sampling for Wildwood Knolls water tank and water house.

Supervisor Annabi said there is a water tank and water house on Oscawana Lake Road in the Wildwood Knolls District. They just want to make sure it is not doing any damage to the ground around it, so we will be testing it. The cost is coming from ARPA Funds, not District Funds. If anything does need to occur, i.e. any sort of removal, it will be discussed with the Wildwood Knolls District to see how they would like to handle it.

## AUTHORIZE THE TOWN SUPERVISOR TO EXECUTE AN INTER MUNICIPAL AGREEMENT FOR THE ALLOCATION AND DISBURSEMENT OF PUTNAM COUNTY AMERICAN RESCUE PLAN ACT OF 2021 (ARPA) FUNDS

#### **RESOLUTION #R22-323**

WHEREAS, the American Rescue Plan Act of 2021 ("ARPA") provides fiscal recovery funds to County Governments, as well as other forms of Government, pursuant to U.S. Department of Treasury Compliance and Reporting Guidance, for the purpose of alleviating the fiscal stress caused by the COVID-19 pandemic; and

WHEREAS, on March 10, 2022, in the State of the County Address to the Putnam County Legislature, County Executive Odell proposed that Putnam County allocate \$5 million of the County's ARPA funds to be used by the County's, Towns, and Villages in conjunction with the \$11 million in ARPA funding received by said municipalities to complete vital projects in Putnam County; and

WHEREAS, the Town has been allocated 12% of the total County Funds, which amounts to \$1,204,284.00, and

**WHEREAS**, the Town submitted several projects which include the implementation of a potable water main; treatment plant installation; sewer pump station; and storm water maintenance;

NOW, THEREFORE BE IT RESOLVED, that the Town Board of the Town of Putnam Valley does hereby authorize the Town Supervisor to execute an Intermunicipal Agreement regarding the allocation and disbursement of such ARPA funds and to execute any formal agreements and associated documents with Putnam County as part of the funding agreement.

One (1) of them is to remove the phosphorous that is running off into Lake Oscawana from Wenonah. As these projects come forward they will be presented to the County for reimbursement.
