PUBLIC HEARING - 30 PORTERS ROAD HOMELAND TOWERS/T-MOBILE

Presented by Supervisor Annabi

Supervisor Annabi introduced David Kenny, Attorney for Snyder & Snyder, who represents Homeland Towers/T-Mobile as they would like to put up a new cell tower at 30 Porters Road in Putnam Valley.

Mr. Kenny made a small presentation to the Town Board and explained he was here in order to obtain a Special Use Permit for the new cell tower and antennas for the T-Mobile Network to be located at 30 Porters Road, which will help fill in the gaps experienced by T-Mobile users. He added that this application has been before the Town for a couple of years now. He said we were before this Board before, and received Concept Approval. We also were before the Planning Board for Site Plan Approval and before the Zoning Board for our variances.

Councilman Smith asked if other cell phone companies will also be utilizing this tower? Mr. Kenny said yes, they have already gotten word from AT&T that they were interested in co-locating below T-Mobil on this tower. We also have a space with free rent for the Town's Emergency Services if they chose to be on this tower as well.

Councilwoman Tompkins asked if there are any other applications for this tower. Mr. Kenny said it is infrastructure, so anything that needs communications devices, it's a support structure. She asked if there are a maximum number of tenants you could have on the structure? Mr. Kenny said it is more designed by the weight rather than the amount. There is always a way to modify the tower if we need to, but we are far away from that now.

Councilman Smith asked when you will be getting the first phone call? Mr. Kenny said as soon as we get the building permit it would take about 30-60 days for the tower to go up.

Councilman Russo asked if the tower ever needs to be taken down, who is responsible for the cost? Mr. Kenny responded by saying as part of our application and our approval with the Planning Board we have to provide a "removal bond" in case the tower ever has to come down.

Mr. Kenny said after we get the Special Use Permit we have to go back before the Planning Board for a "check set approval", so that we can show we are compliant with all their conditions of approval for the site plan. Then after that we will be allowed to go for the Building Permit stage. We are putting the tower where there is an existing abandoned dilapidated house which has to be demolished. We need a permit to do that first before we can go ahead with the permit for the tower.

Highway Superintendent Keeler asked if you are upgrading that road. Mr. Kenny said no there is a private driveway there. We have been reviewing that and if any improvements need to be made we will do that as well.

Supervisor Annabi asked if there was anyone wishing to speak? As there was no Public Comment, Supervisor Annabi said she would leave the Public Hearing open until the next Town Board Meeting on November 16th. She said all comments are welcome.
