#### DISCUSS CONCEPT PLAN FOR HOMELAND TOWERS - 22 LIVING SPRINGS

Supervisor Annabi said that Homeland Towers would like to present their concept plan next week for a proposed cell tower at 22 Living Springs which is off Bryant Pond Road. There are some concerns about their concept plan one (1) being co-locations, i.e. about coverage. We have some questions we are hoping they will be able to answer those concerns. Supervisor Annabi has requested that an outside agency come in and do a study to see if there is a co-location possibility or if another tower is actually needed or not.

Supervisor Annabi made a motion to go into Executive Session to discuss a litigation and personnel matter. No new business will be conducted afterward.

Seconded by Councilman Luongo, unanimously carried.

Supervisor Annabi said she would like to clear up some of the misconceptions regarding PFAS (Per – and Polyfluoroalkyl Substances). She read a passage from the website, FDA.gov as follows:

"Per – and Polyfluoroalkyl Substances (PFAS) are chemicals that have been used in a wide range of consumer and industrial products since the 1940's due to their resistance to grease, oil, water, and heat. For example, PFAS are used in stain and water resistant fabrics and carpeting, cleaning products, paints, and fire-fighting foams. Certain PFAS are also authorized by the FDA for limited use in cookware, food packaging, and food processing equipment. Although PFAS have been in use for more than 80 years, scientific understanding and technical instrumentation needed to test for PFAS at very low concentrations in food began only recently."

Supervisor Annabi said PFAS is a State-wide issue, it is not a Putnam Valley issue. Every Town in Putnam County and almost every Town in the State has a PFAS issue. If you have any questions please go to the website FDA.gov. If you have any questions about your private well call the Putnam County Board of Health.

Supervisor Annabi said next week we will be voting on the Local Laws presented at the last Public Hearings. We will not be voting on the proposed Local Law regarding Opting-Out of our Solar. Right now our Assessor does not assess based on the solar panels on a house. So we are not going to move forward on the opting out of those solar panels. We are going to keep it as it is. It's not affecting the taxes one (1) way or the other because there is no assessed value on that. We will not be voting on this exemption.
