Supervisor Annabi said the above people are our Lake Oscawana Harvester Crew who only get paid through Lake Oscawana. There was a lot of damage in Roaring Brook, in addition to carp issues. These guys were able to remove the carp that got caught in the spillway and the dam. They also removed the dead and decayed carp which took quite a few days.

# AMEND RESOLUTION #R23-235

#### **RESOLUTION #R23-265**

**RESOLVED**, that the Town Board amend Resolution #R23-235. The original Resolution authorizes the expenditure of \$12,033.36 representing payment to the Putnam County Finance Department for back taxes for parcel #65.1-5 on Bell Hollow Road. This parcel of vacant land comprising of 5.734 acres was donated to the Town of Putnam Valley by Jane Hirschman, as per Resolution #R23-146 dated April 12, 2023 in lieu of payment of said back taxes. The Tax map number in the original Resolution is incorrect. The correct tax map number for this property is 62.-1-5 as attached.

#### APPROVE BAN FOR INFRASTRUCTUAL REPAIRS

Presented by Supervisor Annabi

Supervisor Annabi said the cost for repairs which is very high and could not be taken out of our General Fund so we had to go out and get a BAN. We have the highest rating so our interest rate is very low. We only get charged interest on the amount of the BAN that we use. Once we get this approval, Town Clerk Howard will publish this in the newspaper, and 20 days after that we will have the money. Councilman Luongo asked when we get the FEMA money and we pay this back is there any penalty for early repayment. Supervisor Annabi said there is no penalty for that. Councilwoman Tompkins asked if we will get full repayment for what we spend from FEMA. Supervisor Annabi responded, no, we may get back half, we may not. We can't be sure yet of what we will receive. We also may not get this money back for a few years.

#### **RESOLUTION #R23-266**

**RESOLVED,** that the Town Board authorize the issuance of a BAN in the amount of \$8,500,000, which amount is required to repair infrastructural damage in the Town which occurred as a result of the storm on July 10, 2023. The current estimate of such repairs is \$4,032,000 for roads, \$2,950,500 for bridges and retaining walls, \$600,000 for Town buildings, and \$917,500 for Parks and Recreation Facilities. A portion of the disbursement required for repairs will be reimbursed to the Town through FEMA relief funds. The Biden Administration granted public assistance to Putnam County in the wake of the extensive damage incurred throughout the County during the storm; however, the Town must outlay these costs upfront, and apply for reimbursement accordingly.

Supervisor Annabi made the following announcements:

- Supervisor Annabi said President Biden did declare Putnam County a Designated Disaster Zone. This means the funding from FEMA will go towards offsetting some of the infrastructure costs. We are trying to get our residents and businesses that were affected by the storm registered with the County so they may also get some funding. Please go on the County website and register so they can go to the State. Please apply to Putnam Valley Alerts on the Town's website and sign up. Also please go to PutnamCountyNY.com there is a damage self-reporting tool. You click on that tool and report the damage you received at your home or your business. This is not an application for relief. Please call the County at 845-808-1000, Highway Supervisor Keeler at 845-526-3333, or Supervisor Annabi at 845-526-2121 for assistance. In the meantime, take and print lots of pictures. Keep all receipts, and try to keep any other supplies and/or household goods on another receipt.
- We were able to take construction material debris for two (2) weeks after the storm at a special drop-off. We can no longer do this; but our regular bulk drop-off is scheduled for Saturday, August 19<sup>th</sup> from 8:45-11:40 AM. Town Hall Offices are also open that same weekend from 8:00AM to 12:00 PM.
- The Sunset Series Concert featuring Andrea and the Armenian Rug Riders scheduled for August 10<sup>th</sup> has been postponed until September 7<sup>th</sup> at Town Park due to impending bad weather. The next concert featuring Loose Wheel is being held on Thursday, August 24<sup>th</sup> at 7:00 PM.
- Town Day is September 16<sup>th,</sup> Thank-you to AAA Carting, and Putnam Valley Pharmacy for their sponsorships which will go towards our fireworks. We have a lot of great vendors coming and lots of good food. There will be rides for the kids and our fabulous DJ. The road will be closed from 2PM to 10PM so it will be safe to walk from the Elementary School to the Town Park. There are still some vendor spots available, and there a few spots with power still available.
- September 9<sup>th</sup> and 10<sup>th</sup> is the Oktoberfest at the German American Club. Please stop by it's a lot of fun.
- The Town Board Meeting on August 16<sup>th</sup> will have our second Public Hearing on Short Term Rentals. This meeting will begin at 6:00 PM.

Councilman Luongo announced the Putnam Valley Volunteer Fire Department's annual 9/11 Memorial Ceremony is being held at the Town Park at 6:00 PM.

Councilwoman Tompkins asked when the Town Board will be voting on the Short Term Rental Law. Supervisor Annabi said they will be voting in September at the Regular Meeting, unless there are any changes that need to be made.
