DEPARTMENTAL REPORTS

Presented by Supervisor Annabi

New Library Director Amina Chaudhri gave the following report:

Putnam Valley Library Report - October 18, 2023

Adult Services:

In 2022 and 2023 we continued providing educational and entertainment via Zoom programs as well as in person. One experiential program that has been overwhelmingly popular has been our Soundbaths. We have also expanded our monthly program offering to include math tutoring and will soon be adding a craft session on Mondays with any fiber related art. We have Defensive Driving coming up on November 4th, 2023.

We continue to expand our partnerships with community groups and organizations. This year we partnered with the Mental Health Association of Putnam to bring programs for youth, The Prevention Council of Putnam to do Narcan training for staff and community members, and we were even able to install and stock free opioid emergency stations.

The Peekskill Cortlandt Amature Peekskill / Cortlandt Amateur Radio Association continues to hold their monthly meetings as well as co-host various educational programs. They now offer on site testing for licensing free of charge. We also began co-hosting what will be a local chapter of the Sewing Guild of America & will continue to partner with Tompkins Corners and Warner Library among others to reduce the cost of programs and increase attendance and reach of the library's offerings.

Youth Services:

Pumpkin Painting: 102 participants. Lots of nice comments from the parents. Kids could choose not just paint but a variety of stuff (ribbons, stickers, sequins, feathers) that sparked their imagination.

Toddler Story Time: a six-week series about emotions. There is a strong demand for toddler programs, including in the afternoon and afterschool time slots.

Young Authors Reading: Annual program funded by Barry and MJ Ross. Kids who attended the workshops have reported being motivated to continue writing stories and creating more books. See the Young Authors Display Shelf on the main floor of the Library by the elevator.

10/31: Halloween Trick or Treat: we'll take pictures of the costumes and put the photos up for a few days. There will be three story times, including one with actor and library patron Alex Morf.

11/7: Puppet-making workshop: kids will create big whimsical two-dimensional hand puppets with Clarissa Lega, a puppeteer, educator and creative artist.

11/28: Gingerbread Houses decorating workshop!

Library-related Activities:

- Putnam Valley Library Food Pantry: Due to the increasingly cold weather, we
 will be closing our food pantry (located on our front porch) on October 31,
 2023. We will reopen it in the Spring of 2024.
- Children's Librarian/Library Assistant: We are currently hiring for this
 position, and I have posted the job at both MHLS, RCLS, SENYLRC, NYLA
 as well as Rutgers, Drexel, St. John's and SUNY Albany Universities. It's
 also posted on our bulletin board, on Facebook and in the Putnam County
 News and the Highland Current. We interviewed a potential candidate on
 10/17/23.
- Glassolutions: Our new skylight installation completed on September 22.
 2023. Everyone is thrilled with how beautiful the work has turned out and the amount of extra light the Library is now receiving has been a bonus. It was a pretty smooth one and a half day process and Glassolutions left the Children's Room and parking lot in immaculate condition.

Linda Thornton gave the report from the Tompkins Corner's Cultural Center as follows:

Highway Superintendent Keeler's report is as follows:

Good Evening Ladies and Gentlemen

I'd like to take a moment to thank the men and women of the Highway dept. for their hard work and dedication especially over the month

We completed the Hillair Road drainage project in Lake Peekskill we have added 6 basins and 500 ft of 12 inch pipe. Unfortunately we hit quite a bit of ledge rock that needed to be drilled and split. That job took a little longer then had planned. This morning we started a drainage project on Chippewa rd in which it was discovered that there was a failing pipe causing ground disturbance, after further evaluation and the knowledge of my Foreman Dave Conklin we find a way to reroute the storm water, this will require roughly 152 feet of pipe to be redirected and a basin and approximately 200 foot of old rotted metal pipe removed . We will then repair the drainage issue on Muller Mtn road and Woods end Kennels Road

Our blacktop crew has been out patching, repairing berms and filling in cross pieces through out town

The blacktop company will return November 6th and Blacktop Hillair Ann Pl and Elinor and Possibly Cindy Lane and South Street at that time

As we transition out of road work and repairs in the next few weeksyou will be seeing our tree crews out quite a bit this fall and winter cutting down dangerous trees.

Our Vacuum truck has been out every day cleaning basins. It is now in the Barger Street area. We are still hoping for a late winter if so we are hoping to get back to the all lake communities again we should be able to. The guys cleaned 152 basins in the last month 2083 so far year to date

Speaking of winter our mechanics when time allows have begun the process of looking over plows and sanders and making repairs as needed.

Our mower has been out and will remain out through the fall blowing leaves and cutting back anything that may grow. I just want to touch on the mowing for a minute as everyone knows we received a lot of rain this summer and unfortunately the way we got rain 1 day sunshine the next and then rain again the weeds grow like crazy so it was very tough to keep up with and we feel behind yes so I rented a 2nd mower for a month and it helped us greatly .This was the case not only here in Putnam Valley but most of Putnam Westchester and Dutchess counties that I know of.

The phones at highway are now monitored 24 / 7 and I ask residents with issues to call us and not post on Facebook as we don't troll for complaints

Fire Department Chief Frank DiMarco gave the following report:

Fire Department

You'll see by the call reports that we have actually been relatively quiet, or should I say at the normal pace with 35 calls for the month.

We are currently in the midst of concentrating our efforts in recruitment. You should be seeing multiple PSA's on both channel 20 and social media. Putnam Valley Fire Department has been able to maintain a great reputation among the other departments in the county as well as the 911 call center due to our ability to respond to all of our calls. Unfortunately, with people aging out or moving, we are seeing decrease in membership from nearly a hundred to the upper sixties of active members.

I am relatively an easy person to find or contact, so if you would like to have a conversation on what it entails to volunteer, please feel free to reach out to me.

I did want to reiterate that with fall and the cooler weather coming we need to be conscious about starting up if fire places, wood burning stoves and so forth. We also should be careful not to blow leaves in the roadways. Usual calls for the next few months or so are, chimney fire, brush fires due to ash disposal and car accidents due to debris in the roadway. So again, be conscious of those things I mentioned.

These amazing children ran a lemonade stand and the money they raised was donated to help buy security cameras for the Day Camp. CONTINUED PUBLIC HEARING ON REGULATIONS FOR SHORT TERM RENTALS

Supervisor Annabi said the only change that we made from the last Public Hearing is that you may have to add a screening. Town Attorney Ryan said it now authorizes and requires the Planning Board to consider screening where appropriate.

RESOLUTION TO RE-INTRODUCE THE REVISED PROPOSED LOCAL LAW RELATING TO SHORT TERM TRANSIENT RENTALS (STR'S)

RESOLUTION #R23-324

WHEREAS, on June 14th, 2023, the Town of Putnam Valley Town Board proposed that a Town Zoning Code Local Law Amendment be made to Town Code Chapter 165, entitled "Zoning" specifically to create §§165-36.1 adding Short Term Rentals (STR'S) as a particular Special Permit Use; and

WHEREAS, since the initial introduction of the proposed Local Law, said law has underdone additional, substantive, amendments and revisions; and

WHEREAS, the revised proposed amendments are annexed hereto as Exhibit A and incorporated herein as if recited verbatim, and the Town Board does direct that said amendments be spread across the record as if they, in fact, had been read verbatim; and

WHEREAS, the Town Board has determined that the revised proposed amendment must be referred to the Putnam County Department of Planning, Development and Public Transportation for review and recommendation; and

WHEREAS, the Public Hearing relating to these proposed amendments remains open.

NOW, THEREFORE BE IT RESOLVED THAT:

- 1. The Town Board hereby continues the Public Hearing on the revised proposed amendments through November 15, 2023, at 6:00 PM, or as soon thereafter as the matter may be come to be heard, in the Town Hall, 265 Oscawana Lake Road, Putnam Valley, NY; and
- 2. The Town Board refers this matter to the Putnam County Department of Planning, Development and Public Transportation for a recommendation pursuant to GML §239-m; and
- 3. The Town Board directs the Town Clerk to notify the Town Clerks of each of the surrounding Municipalities of the Public Hearing pursuant to GML §239-nn.

By a vote of 4 AYES, and 0 NAYS the Resolution is passed.

Supervisor Annabi said to Town Attorney Ryan that she did have one (1) resident ask a question as follows: If the resident rents his/her house out as an STR before 12/31/2023 even if it's December 1st of 2023, will they still be grandfathered in? Attorney Ryan responded, if they can show proof of operation anytime between 12/31/2022 and 12/31/2023 they will be allowed to continue while they are waiting for their permit. It also does not guarantee that they will get a permit for 2024. Supervisor Annabi said, this does not give anyone priority or grant anyone an automatic permit, so if you are a current STR host or want to be one (1) come January 1, 2024 you both have to follow the same exact procedures. Attorney Ryan said if the Planning Board finds you do not meet the provisions of the code anyone can be denied a permit. If you continue operating and you do not get a permit, you will be fined and brought to court by the Building Inspector. It will be handled just like any other Town Code violation.

Dunderberg Road Resident Lisa Yarusso asked what the purpose for and why is there is another Public Hearing today? Attorney Ryan explained that because we made a change in the law we are allowing people to voice anything they would like to say again. At the meeting on November 15th if the Town Board feels everyone has been heard and the Town Board is satisfied with the law as written they can close the Public Hearing and vote on the law that night. They can also keep the Public Hearing open if they choose as well. Once the Town Board votes, the Town Clerk sends the law to Albany where it gets filed. Attorney Ryan said the Planning Board is up to speed on the latest edition of the law. Attorney Ryan suggested the Town Board adopt the fees and violation fine amounts at the same time they adopt the law.

PUBLIC HEARING OF 2024 BUDGET

Presented by Supervisor Annabi

Supervisor Annabi said everyone has had a chance to look at the budget, it has been available and has been on our website for about a month now. Our budget is well below the CAP at 1.68%. We do have an 8.25 million dollar bond which is going to all damage not just the roadways. This includes our bridges, our culverts, district beaches, Town Park etc. Supervisor Annabi said we have been having a FEMA meeting every Wednesday so they are aware of everything that we are doing. A lot of our jobs will be reimbursed to us by FEMA at around 70%; that will be a very good portion of it. Some of this work will be done "in-kind", meaning from our own Highway Employees. There will be a lot of work and it will mostly be happening all at the same time. Supervisor Annabi said it was a good thing that we added a 5th guy.

Supervisor Annabi thanked our Town Counsel for keeping everyone focused and on task. You do a great job.

PUBLIC HEARING BUILDING THRESHOLD CHANGES

Town Attorney Ryan said last month the Town Board introduced a Local Law increasing the threshold for a new construction or edition that would trigger the requirement to go before the Planning Board. It is public record, but previously the threshold had been in any construction or building an edition, anything over 700 square feet anywhere in any District you had to go before the Planning Board. Now it is broken up by Districts (see law below). This will repeal and replace what is currently in the Zoning Code.

RESOLVED, that the Town Board open the Public Hearing on the Local Law Amending Provisions of the Town of Putnam Valley Zoning Law Relating to Actions Exempted from the Development Approval Plans in Residential Zoning Districts. Town of Putnam Valley Local Law No. ___ of 2023

A Local Law Amending Provisions of the Town of Putnam Valley Zoning Law Relating to Actions Exempted from Development Approval Plans in Residential Zoning Districts

BE IT ENACTED, by the Town Board of the Town of Putnam Valley, Putnam County, New York, as follows:

Part 1. Title

This Local Law shall be known as the "A Local Law Amending Provisions of the Town of Putnam Valley Zoning Law Relating to Actions Exempted from Development Approval Plans in Residential Zoning Districts."

Part 2. Enactment

This Local Law is adopted and enacted pursuant to the authority and power granted by §10 of the Municipal Home Rule Law of the State of New York.

Part 3. Amendment of the Zoning Law

The Town of Putnam Valley Zoning Law is amended as follows:

Replace

Section 165-16(B)(2)(b) "Development Approval Plan;" "Applicability of regulations":

- (2) Any development and use that falls within any Environmental Management District, as defined in Article VI of this chapter, but exempting therefrom:
 - (a) Alterations which do not change or affect the use and occupancy of a building.
 - (b) Enclosed additions to floor space that do not exceed the following:
 - (1) In the LP Zoning District: 800 Square Feet.
 - (2) In the R1 and R2 Zoning Districts: 1,000 Square Feet.
 - (3) In the R3, CD, and PD Zoning Districts: 1,100 Square Feet.

Part 4. Severability

The invalidity of any part or provision (e.g., word, section, clause, paragraph, sentence) of this Local Law shall not affect the validity of any other part of this Law which can be given effect in the absence of the invalid part or provision.

Part 6. Supersession

This Local Law is intended to supersede any provisions of the Town Law, the laws of the Town of Putnam Valley, and the New York State General Municipal Law which are inconsistent with the provisions of this Local Law.

Part 7. Effective Date

This Local Law shall take effect immediately upon the filing with the Office of the Secretary of State of the State of New York, in accordance with the applicable provisions of law, and specifically, Article 3, Section 27 of the New York State Municipal Home Rule Law.

SUPERVISOR'S COMMENTS

Presented by Supervisor Annabi

- Town-wide Bulk Drop-off is October 21st from 8:45-11:45 AM. Town Hall is also open from 8:00 AM - 12:00 noon.
- Sunday, October 22nd is the last Community Shred for the year. If you have any
 documents you want to get rid of please come to Town Hall from 10 AM 2 PM.
 This is a free event.
- On Saturday and Sunday the VFW is having a haunted house. They did a great job. It's startling and spooky not scary.
- Putnam County is holding their Senior Health Fair on Thursday, November 2nd from 10 AM to noon at the Koehler Senior Center on Route 6 in Mahopac. It's for seniors, care takers, and family members of seniors.
- The German-American Club is having a Halloween Party on October 28th.

Supervisor Annabi said a question was raised at the Debate as to whether the Town followed legal procedure for minor tree work performed at the end of March of this year on a property located on Bell Hollow Road. "An accusation was made that the Town performed this tree work for the benefit of the private property owner. I would like to clear up this misunderstanding. This past winter the Town became aware of the deteriorated condition of the Bell Hollow Bridge and began to explore options to repair or replace the bridge with minimal disruption to residents who live on this road. Our Town Engineer proposed a solution that would require a new bridge crossing to be constructed adjacent to the existing bridge in order to avoid a closure. This proposed plan required the Town to purchase or otherwise obtain title to a portion of a privately owned vacant parcel in order to install the new bridge.

Our Town Attorney then began an extensive months' long search for the property owner. The current owner, who lives across the Country, was contacted in April 2023. She was under the impression that her late husband had donated the property to the Town decades ago. No donation was ever made officially, she then expressed her desire to offer the property as a donation to the Town with verbal authorization to enter the property and perform any preliminary work for the eventual bridge repair. In early March, our Town Counsel prepared and sent documents to the property owner which was required to transfer ownership of the donated property and the property owner promptly returned those documents to the Town. Due to a clerical error on the part of the property owner's notary, the transfer documents had to be re-executed.

While the Town was awaiting the corrected documents, the Highway Department performed minor tree work that would ultimately be necessary for the Town's public improvement project. The Town is now the owner of the property and is in the process of obtaining the permits and approvals required to begin the bridge replacement. NO work was performed by Town Employees for the benefit of a private resident; rather any work performed has been for the public health, safety, and welfare of the traveling public and the community of residents who reside on Bell Hollow Road. Thank-you."

Supervisor Annabi said she also wants to clear up another rumor that occurred on Monday which is that the Town, this Board, and the previous Board was aware of illegal dumping at the Fire Department. The Fire Department was aware that there was going to be fill which was ordered. At no time did the Town Board or the Fire Department know the fill was contaminated. At no time did the Town Board or the Fire Department order contaminated fill. When the fill was found to be contaminated the DEC was brought in immediately. When the State Agency was brought in the Town stepped back in regards to the testing of that fill. That was all done between a contracted entity to the Town, which is the Fire Department, and the State DEC. The Town has no jurisdiction with a contracted entity. However, when it came time for the remediation the Fire Department did come to the Town, and it has been filmed, aired, and done in person here at the Town Hall 23 times. From September 23rd, 2019 to February 8th, 2021 there were 23 meetings here-live-televised, with minutes, regarding these issues. Nothing was ever hidden from the public; nothing was ever done to protect or to hide anything. Anybody can order fill, you can go into Facebook and type in the words "free fill" and get it. No one knew it was contaminated, we all live here, no one ordered contaminated fill. Once we found out the fill was contaminated the DEC got involved, the Town got the remediation in place, the Fire Department cleaned that up in 2019. If you have any questions about that Supervisor Annabi will talk about remediation through the minutes, you can get that from our Clerk.

All the minutes regarding a Public Hearing and the remediation are Public Record. There is some sort of litigation going on about getting some of this money back, I cannot talk about the legal ramifications, it is not in the purview of the Town Board because they are a private contracted entity, no different than any other contracted entity. Our Attorney is a contracted entity, I can't tell her how to spend her money. Contracted entities perform a service to the Town and thank you to the Fire Department for everything you do for us, you are always there and you never say no to any community service.

LEGISLATIVE REPORT

Councilman Russo read County Legislator Gouldman's report as follows:

- ** On Monday, October 23, Putnam County will be having another Flu Clinic at the Putnam County Dept of Health, 1 Geneva Road, Brewster, from the hours of 2:00 and 6:00 pm. Supervisor Annabi reminded everyone that there is a three (3) minute talk time limit.

There will be shuttle buses from the German American Club so you can park there and get a ride to my house to view it.
