RESOLUTION AUTHORIZING THE EXECUTION AND SUBMISSION OF A NEW YORK STATE MUNICIPAL HOME RULE REQUEST TO AUTHORIZE THE LEASING OF CERTAIN SPORT FIELD FENCES FOR ADVERTISEMENTS

WHEREAS, the Town of Putnam Valley desires to lease advertising space on municipal sport field fences located in Leonard Wagner Memorial Park; and

WHEREAS, the revenue generated from such leases will be used solely for the Town's Department of Parks and Recreation; and

WHEREAS, on January 3, 2024, New York State Senator Robert Rolison introduced Bill No. S6678-A to the New York State Senate; and

WHEREAS, on January 3, 2024, New York State Assemblyman Matthew Slater introduced Bill No. A6776-A to the New York State Assembly; and

WHEREAS, this legislation requires the passage of a Municipal Home Rule Request to the New York State Senate and Assembly.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Putnam Valley hereby approves and authorizes the submission of a Municipal Home Rule Request for Bill Nos. S6678-A & A6776-A to the New York State Legislature which will permit the Town of Putnam Valley to lease advertising space on municipal sport field fences located in Leonard Wagner Memorial Park; and

BE IT FURTHER RESOLVED, that Supervisor Annabi and the Town Clerk are authorized to execute the Municipal Home Rule Request and deliver all necessary documents to the New York State Legislature.
