Highway Superintendent Keeler's Report is as follows:

Superintendent Keeler started by saying: Obviously, as Keith Haviland is retiring, I would like to welcome Treavor McGee. Treavor started on June 5<sup>th</sup> and jumped right into it. I think he is going to be a great fit.

Good Evening Ladies and Gentlemen

I'd like to take a moment to thank the men and women of the Highway dept. for their continued hard work and dedication

We have added another 44 feet of 12 inch pipe on Posey Road  
We then replaced a 24 inch pipe on Hillside Drive in Brookdale Gardens with 40 Ft. of 36 inch pipe as well as realigned it to alleviate a drainage issue in the area. We moved on to Bonnie wood drive and added a basin as well as 200 Feet of perforated 6in pipe. We replaced old rotted metal pipe with new plastic pipe that was 340 feet of 18 in pipe and 60 feet of 24 inch pipe.

We then have to replace an 18 inch pipe on Morrissey drive as well as Boswell rd. We will then hopefully get started on the Lake Drive drainage project.

We have been out mowing and are hoping that by getting an early start we will be able to stay on top of it

Our Vac-all has been out cleaning basins as well as gutters on the sides of the roads. We cleaned 594 basins in the last month which is 1518 Basins year to date; In 2023 we were only able to clean 1217 basins so we are definitely going to exceed that by far. With getting such an early jump on basins this year we should be able to get all basins cleaned twice this year.

We have been out Blacktop patching all over Town. We also Blacktopped the areas that we replaced drainage on Point Dr as well as Avon Rd.

Speaking of Blacktop Milling will begin on July 8<sup>th</sup> paving will begin on July 10th Posey Rd , Gardineer Rd, North Meadow, Bonnie wood , Boswell, Kenneth dr, North shore, Community Pl, Hilltop Dr, Lookout Pass, Cimmaron Rd, Morrissey Dr, Walnut , Oak , Sunnyside, Sylvan, Chestnut, Pecan Pl, Beech, trail Court, Trail of The Maples ,and if all goes well and we have the funds we will also do Lincoln Rd and Sassinoro dr

The phones at highway are monitored 24 / 7 and I ask residents with issues to call us and not post on Facebook as we don't troll for complaints

**PUBLIC HEARING: PROPOSED LAW ON GROUND MOUNT COMMERCIAL SOLAR ENERGY SYSTEMS**

**Town of Putnam Valley Local Law No. \_\_\_\_ of 2024**

**A Local Law Amending the Town of Putnam Valley Zoning Law Relating to Ground Mount Commercial Solar Energy Systems**

BE IT ENACTED, by the Town Board of the Town of Putnam Valley, Putnam County, New York, as follows:

**Part 1. Title**

This Local Law shall be known as the “A Local Law Amending the Town of Putnam Valley Zoning Law Relating to Ground Mount Commercial Solar Energy Systems.”

**Part 2. Enactment**

This Local Law is adopted and enacted pursuant to the authority and power granted by §10 of the Municipal Home Rule Law of the State of New York.

**Part 3. Amendment of the Zoning Law**

The Town of Putnam Valley Zoning Law is amended as follows:

*Replace*

Section 165-111(D) “Solar Energy Systems”: Commercial solar energy systems. Due to the potential negative impacts to neighborhood character and to other environmental resources from commercial activity related to energy generation, supply and transmission in residential zones, commercial solar energy systems are strictly prohibited in all residential and CD and PD Zoning Districts in the Town. Ground mount commercial solar energy systems shall not be permitted in any zoning district or area of the town with the exception of installations constructed above existing or approved impervious surfaces or remediated contaminated sites as defined by the New York State Department of Environmental Conservation (NYSDEC). A commercial solar energy system shall be permitted only as a special permit use in Commercial Zoning Districts. Commercial Building-Integrated Photovoltaic Systems shall be subject to the following requirements (in addition to the requirements for a special permit application and site plan review).

**Part 4. Severability**

The invalidity of any part or provision (e.g., word, section, clause, paragraph, sentence) of this Local Law shall not affect the validity of any other part of this Law which can be given effect in the absence of the invalid part or provision.

**Part 6. Supersession**

This Local Law is intended to supersede any provisions of the Town Law, the laws of the Town of Putnam Valley, and the New York State General Municipal Law which are inconsistent with the provisions of this Local Law.

**Part 7. Effective Date**

This Local Law shall take effect immediately upon the filing with the Office of the Secretary of State of the State of New York, in accordance with the applicable provisions of law, and specifically, Article 3, Section 27 of the New York State Municipal Home Rule Law.

Supervisor Annabi said last month we presented to our public some changes to our codes. The first one is an amendment to our Zoning Law relating to Ground Mount Commercial Solar Energy Systems.

This Public Hearing is to discuss "Solar Energy Systems": Commercial solar energy systems. Due to the potential negative impacts to neighborhood character and to other environmental resources from commercial activity related to energy generation, supply and transmission in residential zones, commercial solar energy systems are strictly prohibited in all residential and CD and PD Zoning Districts in the Town. Ground mount commercial solar energy systems shall not be permitted in any zoning district or area of the town with the exception of installations constructed above existing or approved impervious surfaces or remediated contaminated sites as defined by the New York State Department of Environmental Conservation (NYSDEC). A commercial solar energy system shall be permitted only as a special permit use in Commercial Zoning Districts. Commercial Building-Integrated Photovoltaic Systems shall be subject to the following requirements (in addition to the requirements for a special permit application and site plan review).

Sam Oliverio, a Crescent Lane resident spoke about the solar panels on Foothill Street near the high school and middle school campus causing devastation of a beautiful forest. This property was allowed to be leased to Con Edison. Trees were wiped out and a habitat for flora and fauna was wiped out regardless of protests from town residents here at Town Hall, at our school district and at Yorktown's Town Board.

This is an absolute disaster and cannot be allowed. Yorktown has not been a good neighbor to us by allowing this. If you are going to put solar panels up, put them in open farmlands, on top of buildings or parking lots. Also, what do we do with these panels after their use is over? They go into landfills. I applaud the Town Board for doing this moratorium.

Patty Villanova, a West Avenue resident said she totally agrees with Sam Oliverio. She said the biggest problem we have is New York State. New York's Climate Leadership and Community Protection Act is their "Green New Deal" and is causing this devastation. They want to get to net "0" by 2040 to achieve 100% zero emission electricity. Impossible goals. The State can override Town laws and she does not believe we can supersede it. Supervisor Annabi asked if she supports this amendment and she said Yes, she supports it 100%.

Supervisor Annabi said this is just to put this on the books so the State knows we are against it.

Judy Allen, a member of Sustainable Putnam

An outright prohibition of clean energy projects is an all-or-nothing response that will set back progress toward our urgent climate goals. Sustainable Putnam believes there are better approaches than an outright ban or moratorium. Specifically, balanced regulations that evaluate and regulate the permitting of clean energy projects with specific criteria are more appropriate and beneficial to Putnam Valley — and our county, region, and planet.

Rejecting all clean energy projects across the board would be short-sighted and harmful to our urgent climate solution goal to reduce fossil fuel emissions that are escalating climate impacts.

Let's not establish *absolute* prohibitions on *all* clean energy projects. That's throwing the baby out with the bath water.

1. Everything we construct has some negative ecological impact. Roads, bridges, fire houses, schools. We build what is useful and desirable, with an eye toward conserving what we value: natural environment, aesthetics, recreational opportunities, agricultural resources, etc. The question we should be asking regarding any proposed development is, does the positive impact outweigh the negative?
2. Why do we need clean energy projects (such as solar and battery energy storage)? We need these technologies because their positive ecological impacts generally outweigh their negative impacts. Again, they must be sized and sited appropriately, while evaluating other ecological impacts. These technologies' greatest strength is their *net reduction* in climate-changing greenhouse gases. They allow us to replace the burning of fossil fuels to generate electricity, and help balance out our peak power demands. (Currently, peak power is supplied by our least efficient and dirtiest "peaker plants.") Second, our region's power is mostly

imported from Canada and upstate New York. That makes it less reliable and vulnerable to interruptions. We need to do our part to develop additional clean energy resources right here in Putnam County.

3. For clean energy projects, holistic and rational decisions are needed, rather than a knee jerk rejection, such as a moratorium or prohibition.
4. For example, clear cutting trees to install ground mount solar panels is *ecologically counter-productive* (cutting trees decreases carbon sequestration and biological diversity, erodes soil, increases stormwater runoff, etc.). Those negative impacts outweigh the positive clean energy impact of replacing fossil fuels, etc. Such projects should be rejected.
5. On the other hand, ground mounted solar on *already-cleared land* or battery energy storage sites (BESS) that are *appropriately sited and sized* are badly needed climate solutions and should not be rejected out of hand. Again, let's not establish absolute moratoriums or prohibitions of all clean energy projects.
6. We can establish zoning and permitting processes that limit or prohibit only those projects with a mostly negative impact, while allowing those clean energy projects with a mostly positive impact.

This balanced perspective isn't difficult to determine or regulate, but it isn't a black and white decision (moratorium or prohibition) either.

Attorney Ryan explained that a moratorium is a legal pause on accepting and processing applications. By its nature it is temporary. It allows the Town the opportunity to look at its laws and amend them to reflect what changes have come up or what issues are facing the Town.

Pam Acevedo, a Lee Avenue resident said she disagrees with Sam Oliverio saying it is good for farmlands. There are solar panels on farmlands near Club Fit that ruined and destroyed the environment. Would the new law prevent panels on our farmlands?

Attorney Ryan said the law limits the commercial fields to parking lots or areas with impervious surfaces, not farmlands.

Tom Pendelton, a Peekskill Hollow resident said he came here for the greenery and lakes and supports sustainability. Don't allow clear-cutting and destruction of the beautiful things that we have here in Putnam Valley.

Nick Kuvach, a Putnam Valley resident said that many municipalities in the United States are mandating installation of solar panels on rooftops of box stores and implementing the installation of solar panels on reservoirs, mitigating evaporation and retarding the growth of algae. Are any of these considerations applicable to Putnam Valley?

Jeff Coren, a Putnam Valley resident said he is representing the CCE. What they are working on is the Open Space Inventory which will provide the Town with a lot of information on what spaces might be useful in various different ways and to avoid the destruction of the environment.

Ina Cholet, a Lake Shore Road resident, agrees with Sam Oliverio's description of what happened in the Yorktown process. We shouldn't limit ourselves, but allow ourselves to adjust with new technology. By evaluating each project by itself may be a preferable way to do things. She is totally in favor of what Mr. Oliverio said and is totally in favor of the goals of the bill.

Gerry Katsban, a Putman Valley resident agrees with 95% of what Mr. Oliverio said. He feels it cannot be an all-or-nothing, knee-jerk response to this. We need to protect the natural environment, yet what do we do? We are way behind the curve protecting the environment. We must all figure out what is coming our way and evaluate the solutions.

Nancy Bobrowitz, a Putnam Valley resident said we should spend our time figuring out where we can embrace "green projects".

Supervisor Annabi wanted to clarify for everyone why we are amending this code. This code here is preventing Solar Energy Systems from going into Preservation Districts, Conservation Districts and residential areas, and any applicant that comes forward must have a special use permit. We are not saying "No" across the board; we are limiting it to where people must have a special permit and only for certain areas. We are doing this to

protect our community and our environment and this amendment to the Code is doing just that.

Counsel said this Local Law about solar energy is not subject to a moratorium; this is simply an amendment to the Code that exists right now.

Patty Villanova also said that there are other questions coming up in the context of where we are going with these laws and it is disturbing.

Sarah, a Putnam Valley resident asked is it also open to allowing commercial solar on land that does not have forests?

Counsel said currently this would limit it to commercial districts and it could be placed in a site that has undergone remediation.

Supervisor Annabi said this Public Hearing will remain open for written comments only until July 9<sup>th</sup> at 4 PM. At our next Town Board meeting on July 10<sup>th</sup> at 6 PM the Town Board will be voting on it.

**PUBLIC HEARING: REPEALING LOCAL LAW RELATED TO INCENTIVE ZONING**

**Town of Putnam Valley Local Law No. \_\_\_\_ of 2024**

**A Local Law Repealing Article XXIII of the Town of Putnam Valley Town Code Relating to  
Incentive Zoning**

BE IT ENACTED, by the Town Board of the Town of Putnam Valley, Putnam County, New York,  
as follows:

**Part 1. Title**

This Local Law shall be known as the “A Local Law Repealing Article XXIII of the Town of  
Putnam Valley Town Code Relating to Incentive Zoning.”

**Part 2. Purpose**

The purpose of this local law is to repeal Local Law #9 of 2010, which authorized the Town Board  
to grant incentives to the private sector engaged in the land development process.

**Part 3. Enactment**

This Local Law is adopted and enacted pursuant to the authority and power granted by §10 of the  
Municipal Home Rule Law of the State of New York.

**Part 4. Amendment of the Town Code**

The Town of Putnam Valley Code Article XXIII, §§165-103 through 110 is amended as follows:  
*Repealed in its entirety.*

**Part 5. Severability**

The invalidity of any part or provision (e.g., word, section, clause, paragraph, sentence) of this  
Local Law shall not affect the validity of any other part of this Law which can be given effect in  
the absence of the invalid part or provision.

**Part 6. Effective Date**

This Local Law shall take effect immediately upon the filing with the Office of the Secretary of  
State of the State of New York, in accordance with the applicable provisions of law, and  
specifically, Article 3, Section 27 of the New York State Municipal Home Rule Law.

Supervisor Annabi said this is a discussion regarding the repealing of Article XXIII of the  
Town Code relating to Incentive Zoning.

The purpose of this local law is to repeal Local Law #9 of 2010, which authorized the  
Town Board to grant incentives to the private sector engaged in the land development  
process.

The Board is looking to repeal this code and looking for the Town to see if they are in  
support of repealing this code.

Counsel said this law now states that if a commercial developer comes in to town and the zoning does not meet what they want to do there, they could offer an incentive to the Town by donations of lands or funds to the Town to be used for specific purposes. The Town Board had been under the opinion that this law had been repealed years ago. It hadn't, so this is to correct it and make everyone subject to the zoning which is on the Zoning Map and the Town Code as it exists.

Patti Villanova said she was not aware of this law. Is there any reason why the Board wants to repeal it at this time?

Supervisor Annabi said the Board believed the code was repealed, yet it wasn't, so they are doing their due diligence by repealing it.

Pam Acevedo was confused about the law. If someone wanted to develop something and it wasn't allowed, they would come before the Town Board and ask for a special use permit to do what they want to do and they would give an incentive?

Counsel said that would essentially be a request to re-zone that parcel. They would present the Town Board with a trade. This repeal would take away that option. There still is a way for the Town to re-zone, but this would prevent a land swap. Zoning will then be by way of zoning laws that are on the books.

Sam Oliverio said this makes everyone follow the zoning code on an equal basis and he applauds the Board on this.

Supervisor Annabi said this Public Hearing will remain open for written comments only until July 9<sup>th</sup> at 4:00 PM. At the next Town Board meeting on July 10<sup>th</sup> at 6:00 PM the Town Board will be voting on it.

**PUBLIC HEARING: PROPOSED TOWING LAW**

The next on the agenda is our "Towing List".

Supervisor Annabi read the following:

**Declaration of purpose.**

It is hereby declared and found that it is of vital importance to the traveling public that disabled vehicles be removed from the highways as promptly as possible; that delay in removal results in traffic congestion and may cause additional accidents; that the towing of disabled motor vehicles from the highways of the Town of Putnam Valley is a matter affecting the public interest and consequently should be subject to supervision and administrative control for the purpose of safeguarding the public against traffic problems and confusion at the scene of accidents, fraud and excessive rates and similar abuses. To serve these ends, the Town Board establishes a towing list to be made available for use by responding police agencies.

Right now only out-of-town towing companies are available at an exorbitant expense to our residents. We are establishing a protocol where if a tow company has a yard in town and a permit from our Town Clerk, they will be able to be on this list which we will give to our police departments (our Sheriff and State Troopers.) This allows only up to 6 yards. They must be permitted by our Town Clerk and must abide by all DLT regulations. This is only for police and troopers to call off of this list. Residents can use whichever towing company they wish.

Councilman Luongo said this idea started 5-6 years ago and by the time the Town finished clearing the legal end of it this took this long.

Attorney Ryan said this law does not mandate that State Police or the County Sheriff call a company in the Town but it allows towing companies to be certified by the Town and have all the equipment necessary to be called.

Before going to the next Public Hearing which has to do with Solar Energy and Large Scale Energy Conversions, Supervisor Annabi just wanted to say that renewable energies are going to be a bigger part of our lives. It is a trend that is getting bigger and we have to do something. What we are presenting is a 12 month moratorium for the Town to look into the establishment of Large-Scale Battery Energy Storage System Installations, and Large-Scale Wind Energy Conversion Systems Within the Town of Putnam Valley.

**PUBLIC HEARING: MORATORIUM ON BATTERY STORAGE UNITS**

Supervisor Annabi along with Councilmen Russo and Luongo read the following:

**SECTION 2. STATUTORY AUTHORITY; PURPOSE AND INTENT.**

This Local Law is intended to be consistent with and is adopted pursuant to the authority granted to the Town Board of the Town of Putnam Valley under the New York State Constitution, and the Laws of the State of New York, including but not limited to the following authorities: New York State Constitution Article IX, Section 2 (c)(ii)(6), (10); Municipal Home Rule Law § 10(1)(i); Municipal Home Rule Law § 10(1)(ii)(a)(6), (11), (12), and (14); Municipal Home Rule Law § 10(1)(ii)(d)(3); Municipal Home Rule Law § 10(2); Municipal Home Rule Law § 10(3); Municipal Home Rule Law § 10(4)(a), and (b); Statute of Local Governments §10(1), (6), and (7); Town Law § 64 (17-a); Town Law § 130(3) and (15); Town Law §135; Town Law Article 16 (Zoning & Planning) inclusive; Environmental Conservation Law §3-0301(1)(b), 3- 0301(2)(m) and 8-0113 and 6 NYCRR Part 617, also known as the State Environmental Quality Review Act, as it pertains to applications that are neither excluded nor exempt from this local law.

This Local Law is a land use regulation. This Local Law is intended and is hereby declared to address matters of local concern, and it is declared that it is not the intention of the Town to address matters of statewide concern. This Local Law is intended to act as and is hereby declared to exercise the permissive “incidental control” of a zoning law and land use law that is concerned with the broad area of land use planning and the physical use of land and property within the Town, including the physical externalities associated with certain land uses, such as potential negative impacts of such uses on a community.

This Local Law shall supersede and suspend those provisions of the Zoning Ordinance of the Town of Putnam Valley and New York state law which require the Planning Board and/or the Town Code Enforcement officer to accept, process, and approve land use applications within certain statutory time periods.

This Local Law is intended to temporarily prohibit the creation or siting of Large-Scale Battery Energy Storage System Installations, and Large-Scale Wind Energy Conversion Systems (as herein later defined) within the Town of Putnam Valley for a period of up to twelve (12) months, pending the development and adoption of local laws and/or ordinances designed to regulate and govern such installations.

The Town Board recognizes and acknowledges that the Town needs to study and analyze many considerations that affect the preparation of local legislation to regulate the future creation and siting of Large-Scale Battery Energy Storage System Installations, and Large-Scale Wind energy Conversion Systems. The Town Board has formally requested the Building and Zoning Department and the Planning Board of the Town of Putnam Valley to identify and review local laws from other jurisdictions, and related information and source materials, in order to assist in developing the parameters of a local law to regulate of Large-Scale Battery Energy Storage

System Installations, and Large-Scale Wind energy Conversion Systems . The Town Board has directed the Town Attorney to assist in this endeavor.

The Town Board also recognizes the need to review and examine its existing ordinances, local laws, and Zoning Ordinance provisions insofar as they may be affected by adoption of such local law(s) regulating the creation and/or siting of Large-Scale Battery Energy Storage System Installations, and Large-Scale Wind Energy Conversion Systems. It is deemed necessary to enact this moratorium in order to permit the Town adequate time in which to draft suitable legislation for this purpose. During the term of the moratorium the Town of Putnam Valley shall work to prepare and eventually adopt new land use regulations to incorporate into the Town's existing Zoning Ordinance.

At this time, there are no pending applications for the location, development, or site plan approval of a Large-Scale Battery Energy Storage System Installation, and/or Large-Scale Wind Energy Conversion System.

During the pendency of the moratorium, the Town Board will consider how best to permit such installations so as to harmoniously integrate such installations with the existing community and landscape. At present, the Zoning Ordinance of the Town of Putnam Valley may not adequately regulate such land use. If the community allows such development during that time, the goals of the Town Zoning Code and its related legislation favoring the preservation and support of scenic, cultural, aesthetic, historic, environmental, and other resources of the Town of Putnam Valley could be undermined or damaged. Moratoria are useful in controlling or temporarily inhibiting development until satisfactory final regulations are adopted.

For these reasons, the Town Board finds that temporary moratorium legislation is both advisable and necessary for a reasonable and defined period of time in order to develop and adopt necessary zoning and land use changes to the Zoning Ordinance of the Town of Putnam Valley, thus protecting and furthering the public interest, health, and safety.

Supervisor Annabi said this moratorium allows the Town to look into the Open Space Inventory presented by the CCE. There is a lot to look into. There is no law on the books but this will prevent any applications to come in front of the Town Board until we do our due diligence.

Sam Oliverio said he applauds the board for going forward with this moratorium. There is much controversy regarding the Mahopac Battery Storage Facility. A lithium battery fire of a storage unit size would be devastating. It is unbelievably difficult to put out. Not knowing the science behind it and doing a moratorium is good sense.

Patty Villanova also thanked the Board for this moratorium and appreciates them doing the right thing. She thinks it's "Great" and "Thank You".

This Public Hearing will remain open for written comments only until July 9<sup>th</sup> at 4:00 PM. At our next Town Board Meeting on July 10<sup>th</sup> at 6:00 PM the Town Board will vote on it.
