WHEREAS, on or after June 3, 2024, New York State Senator Robert Rolison introduced Bill No. S6678B to the New York State Senate; and

WHEREAS, on or after June 3, 2024, New York State Assemblyman Matthew Slater introduced Bill No. A6776B to the New York State Assembly; and

WHEREAS, this legislation requires the passage of a Municipal Home Rule Request to the New York State Senate and Assembly.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Putnam Valley hereby approves and authorizes the submission of a Municipal Home Rule Request for Bill Nos. S6678B & A6776B to the New York State Legislature which will permit the Town of Putnam Valley to lease advertising space on municipal sport field fences located in Leonard Wagner Memorial Park; and

BE IT FURTHER RESOLVED, that Supervisor Annabi and the Town Clerk are authorized to execute the Municipal Home Rule Request and deliver all necessary documents to the New York State Legislature.
