### RESCIND RBL DAM BID ACCEPTANCE

### **RESOLUTION #R24-279**

**RESOLVED**, that the Town Board vote to rescind Resolution #R24-243, rescind the notice of award, and reject all bids received for the Roaring Brook Lake Dam Rehabilitation project.

This Resolution was "read per verbatim".

WHEREAS, the Town of Putnam Valley is in the process of planning and permitting a public improvement project to rehabilitate the dam at Roaring Brook Lake ("Roaring Brook Lake Dam Rehabilitation Project" or "the Project"); and

WHEREAS, the Town underwent a public bidding process for the Project, pursuant to the requirements of GML §103 and the Town of Putnam Valley Procurement Policy; and

WHEREAS, two (2) bids were received and opened on May 10, 2024 in the presence of the Town Clerk, the Town's District Clerk, and representatives of the companies that submitted the bids; and

WHEREAS, according to the minutes taken at the bid opening, the Bid Package submitted by the lowest bidder (Doyle Contracting, Inc.) did not include the GML §§103-a & 103-d Certification; and

WHEREAS, pursuant to the bid opening minutes and the apparent deficiency noted therein, the Project was awarded to the second bidder (Con-Tech Construction Technology, Inc.) on June 12, 2024 by Town Board Resolution #R24-243; and

WHEREAS, after the bid had been awarded, Doyle Contracting, Inc. initiated a dispute and argued that the GML §§103-a & 103-d Certification was, in fact, included in the Bid Package and, therefore, the Bid was improperly awarded to Con-Tech Construction Technology, Inc.; and

WHEREAS, a review of the Town's records revealed that the GML §§103-a & 103-d Certification was included in the Bid Package submitted by Doyle Contracting, Inc.; and

WHEREAS, the Town Board desires to remediate and correct any deficiencies resulting from the May 10, 2024 Bid Opening by restarting the public bidding process for the Project in its entirety.

NOW, THEREFORE BE IT RESOLVED, that the Town Board hereby rescinds Resolution #R24-243 which awarded the Project to Con-Tech Construction Technology, Inc.; and

BE IT FURTHER RESOLVED, that the Town Board hereby rescinds the Notice of Award to Con-Tech Construction Technology, Inc., dated June 13, 2024; and

BE IT FURTHER RESOLVED, that the Town Board hereby rejects both Bids received and opened on May 10, 2024; and

BE IT FURTHER RESOLVED, that the Town Clerk and WSP USA, Inc. ("WSP"), the Town's dam remediation consultant, are hereby directed and authorized to put the Roaring Brook Lake Dam Rehabilitation project out for new bids.
